## **RESOLUTION NO. 18-2014**

## TOWN OF YORKVILLE RACINE COUNTY, WISCONSIN

## A RESOLUTION ADOPTING THE 2014 PROPERTY TAX LEVY FOR THE TOWN OF YORKVILLE

THE ELECTORS OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVE AS FOLLOWS:

WHEREAS, the Yorkville Town Board and all subunit committees of the Town of Yorkville, through the budgeting process, are responsible for appropriating the funds necessary for the efficient and responsible operation of the government, administration and operation of the Town of Yorkville and all its subunits for 2015, and

WHEREAS, the Yorkville Town Board recommended, on October 24, 2014, that \$1,037,686.00 in property tax revenue be collected to help achieve these goals, and

WHEREAS, the Yorkville Water Utility Commission recommended, on October 21, 2014, pursuant to Wisconsin Statutes 196.03(3)(b) and in proportion to the 2014 assessed valuations in the Yorkville Water Utility District No. 1, that \$92,575.00 in property tax revenue be collected to help achieve these goals, and

WHEREAS, the Yorkville Town Board held a public hearing on the proposed 2015 Town budget on November 17, 2014, and

WHEREAS, Wisconsin Statutes 60.10(1)(a) authorizes town electors to adopt a tax levy at a special town elector meeting, and

**WHEREAS**, a Special Town Elector Meeting has been called and noticed, pursuant to Wisconsin Statutes 60.12, on November 17, 2014, by the Town of Yorkville for this purpose.

**NOW, THEREFORE,** by majority vote of eligible electors duly assembled and voting on November 17, 2014, at the Special Town Elector Meeting of the Town of Yorkville, Racine County, Wisconsin,

**BE IT RESOLVED,** that said Electors hereby adopt a 2014 Town tax levy to be collected in 2015 in the amount of \$1,130,261.00, and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to distribute said taxes upon the current tax roll of the Town of Yorkville, and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption as required by Wisconsin Statutes 60.80(1), and

BE IT FURTHER RESOLVED, that this resolution take effect the day following its posting.

This Resolution was adopted by Electors of the Town of Yorkville at a Special Town Elector Meeting on November 17, 2014.
