RESOLUTION NO. 19-2014

TOWN OF YORKVILLE RACINE COUNTY, WISCONSIN

A RESOLUTION ADOPTING THE 2015 BUDGETS AND 2014 PROPERTY TAX LEVIES FOR THE TOWN OF YORKVILLE

THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVES AS FOLLOWS:

WHEREAS, the Yorkville Town Board, per Section 46-121 of the Town of Yorkville Code of Ordinances, is responsible for preparing an annual budget for the efficient and responsible operation of the government, administration and operation of the Town of Yorkville, and

WHEREAS, the Yorkville Town Board recommended a 2015 annual General Fund budget to help achieve these goals on October 24, 2014, and

WHEREAS, the Yorkville Sewer Utility District Commission recommended a 2015 annual Sewer Utility Fund budget to help achieve these goals on October 21, 2014, and

WHEREAS, the Yorkville Water Utility District Commission recommended a 2015 annual Water Utility Fund budget to help achieve these goals on October 21, 2014, and

WHEREAS, the Yorkville Stormwater Utility District Commission recommended a 2015 annual Stormwater Utility Fund budget to help achieve these goals on October 27, 2014, and

WHEREAS, the Yorkville Town Board, after proper notice was given in accordance with Wisconsin Statutes 65.90(3)(a)(1), held a public hearing on the proposed 2015 annual budget for these four bodies on November 17, 2014, and

WHEREAS, the electors of the Town of Yorkville, by majority vote at a Special Town Elector Meeting on November 17, 2014, adopted a 2014 Town tax levy to be collected in 2015 in the amount of \$1,130,261.00, and

WHEREAS, the electors of the Town of Yorkville, by majority vote at a Special Town Elector Meeting on November 17, 2014, approved 2015 highway expenditures in the amount of \$728,046.46.

NOW, THEREFORE, BE IT RESOLVED, that the Yorkville Town Board hereby adopts the 2015 Town annual General Fund budget in the amount of \$1,455,315.48, and

BE IT FURTHER RESOLVED, that the Yorkville Town Board hereby adopts the 2014 tax levy (to be due in 2015) in the amount of \$1,130,261.00 and authorizes and directs the Clerk-Treasurer to distribute the same upon the 2014 tax roll, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2014 tax roll against respective properties, pursuant to Wisconsin Statutes 66.0809(3), unpaid and delinquent sewer utility charges and penalties of Yorkville Sewer Utility District No. 1 in the amount of up to \$10,366.72, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2014 tax roll against respective properties, pursuant to Wisconsin Statutes

66.0809(3), unpaid and delinquent water utility charges and penalties of Yorkville Water Utility District No. 1 in the amount of up to \$1,623.05, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2014 tax roll against respective properties stormwater special assessment charges in the amount of \$54,872.00, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2014 tax roll, in proportion to the 2014 assessed valuations of the Town, the following tax levies:

- 1. Racine County \$1,959,137.03
- 2. Racine County Children with Disabilities \$100,716.85
- 3. State of Wisconsin \$84,615.73
- 4. Union Grove Grade School \$523,331.87
- 5. Yorkville Grade School \$3,435,207.00
- 6. Union Grove High School \$2,102,914.29
- 7. Gateway Technical College \$384,079.26, and

BE IT FURTHER RESOLVED, that the 2015 Yorkville Sewer Utility District No. 1 budget of \$300,479.90 be hereby adopted, and

BE IT FURTHER RESOLVED, that the 2015 Yorkville Water Utility District No. 1 budget of \$173,342.72 be hereby adopted, and

BE IT FURTHER RESOLVED, that the 2015 Yorkville Water Utility District No. 1 tax equivalency charge, created pursuant to Wisconsin Statutes 66.0811(2), be set at \$17,714.28, and

BE IT FURTHER RESOLVED, that the 2015 Yorkville Stormwater Utility District budget of \$179,890.00 be hereby adopted, and

BE IT FURTHER RESOLVED, that the 2015 Union Grove-Yorkville Fire Department budget of \$581,958.00 be hereby adopted, with Yorkville's share of said budget being \$195,277.00, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, as required by Wisconsin Statutes 60.80(1), and

BE IT FURTHER RESOLVED, that this resolution take effect the day following its posting.
