**A RESOLUTION DESIGNATING AND APPOINTING COMMITTEE MEMBERS
TO VARIOUS POSITIONS IN TOWN OF YORKVILLE GOVERNMENT**

**THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN,
RESOLVES AS FOLLOWS:**

WHEREAS, the following appointment terms expire, effective April 30, 2015:

1. Plan Commissioner, 3-year term;
2. Plan Commissioner, 3-year term;
3. Plan Commissioner (Town Board representative on the Plan Commission), 1-year term;
4. Plan Commissioner (Town Board representative on the Plan Commission), 1-year term;
5. Stormwater Commissioner, 5-year term;
6. Stormwater Commissioner (Town Board representative on the Stormwater Commission), 1-year term;
7. Stormwater Commissioner (Plan Commission representative on the Stormwater Commission), 1-year term;
8. Board of Review Member (Citizen representative), 3-year term;
9. Board of Review Member (Citizen representative – alternate), 3-year term; and

WHEREAS, Town of Yorkville Code of Ordinances Section 2-81 provides for the designation and appointment of all members of any standing and special committee established by the Town Board by the Town Board Chairperson, which shall be subject to confirmation by a majority vote of the Town Board, and

WHEREAS, Town of Yorkville Code of Ordinances Section 2-202 provides for the staggered designation and appointment of citizen Plan Commissioner members for three-year terms, which shall be subject to confirmation by a majority vote of the Town Board, and

WHEREAS, Town of Yorkville Code of Ordinances Section 54-277 provides for the staggered designation and appointment of Yorkville Stormwater Utility District Commissioner members for five year terms, which shall be subject to confirmation by a majority vote of the Town Board.

NOW, THEREFORE, BE IT RESOLVED, that the Yorkville Town Board designates and appoints the following individuals to the following positions with terms of office to expire on the following dates:

1. Gary Fink, Plan Commissioner, April 30, 2018;
2. Nathan Skewes, Plan Commissioner, April 30, 2018;
3. Sherry Gruhn (Town Board representative on the Plan Commission), Plan Commissioner, April 30, 2016;
4. Peter Hansen (Town Board representative on the Plan Commission), Plan Commissioner, April 30, 2016;
5. Sherry Gruhn (Town Board representative on the Stormwater Commission), Stormwater Commissioner, April 30, 2016;
6. Robert Root (Plan Commission representative on the Stormwater Commission), Stormwater Commissioner, April 30, 2016;
7. Barbara Geschke (Citizen representative on the Board of Review), April 30, 2018;

8. Karen Peterson (Citizen representative on the Board of Review – alternate), April 30, 2018;
and

BE IT FURTHER RESOLVED, that each of these new appointment terms shall begin on May 1, 2015, and

BE IT FURTHER RESOLVED, that no appointment be made to the position of Stormwater Commissioner until such time as a suitable candidate is identified, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, as required by Wisconsin Statutes Section 60.80(1), and

BE IT FURTHER RESOLVED, that this resolution takes effect the day following its posting.
