## **RESOLUTION NO. 16-2014**

## TOWN OF YORKVILLE RACINE COUNTY, WISCONSIN

A RESOLUTION APPOINTING THE TOWN OF YORKVILLE'S CLERK-TREASURER AND DEPUTY CLERK-TREASURER AS ELECTION DAY SPECIAL REGISTRATION DEPUTIES FOR THE NOVEMBER 4, 2014 FALL GENERAL ELECTION

THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVES AS FOLLOWS:

WHEREAS, the right to vote is an essential component of a free and democratic society, and

WHEREAS, the right to vote depends upon an efficient voter registration process, and

WHEREAS, anticipated voter turnout for the Fall General Election on November 4, 2014, may require additional assistance with voter registrations, and

WHEREAS, Wisconsin Statutes Section 6.55(6) states that the governing body of any municipality may provide by resolution for the appointment of an Election Day Special Registration Deputy at the polling place to carry out the registration duties described in Wisconsin Statutes Section 6.55(2), and

WHEREAS, Wisconsin Statutes Section 7.30(2)(a) states that any municipal Clerk or Deputy Clerk may be appointed as an Election Day Special Registration Deputy, and

WHEREAS, the Clerk-Treasurer and Deputy Clerk-Treasurer both meet the minimum qualifications necessary to serve as an Election Day Special Registration Deputy as outlined in Wisconsin Statutes Section 7.30(2)(a).

NOW, THEREFORE, BE IT RESOLVED, that, in furtherance of an efficient voter registration process, the Yorkville Town Board hereby appoints the Town of Yorkville's Clerk-Treasurer and Deputy Clerk-Treasurer as Election Day Special Registration Deputies for the Fall General Election on November 4, 2014, and

BE IT FURTHER RESOLVED, that these appointments shall terminate upon the closing of the polls on that same date, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, as required by Wisconsin Statutes 60.80(1), and

BE IT FURTHER RESOLVED, that this resolution takes effect the day following its posting.

This resolution was adopted by the Yorkville Town Board on October 13, 2014.
