## Call to Order

Water Utility District Commission President Peter Hansen called the meeting to order at 7:17 p.m.

### Roll Call

The following Water Utility District Commission members were present: Peter Hansen, Sherry Gruhn, Terrence McMahon, Thomas Johnson and Lawrence Robers. Also present were Engineer Mark Madsen, Water Utility District Manager Gary Hanson and Clerk-Treasurer Michael McKinney.

#### Approval of Minutes

Motion (Gruhn, McMahon) to approve the November 18, 2014 Water Utility District Commission meeting minutes as submitted, Motion Carried (MC).

#### Approval of Financial Reports

Motion (McMahon, Robers) to approve the November Water Utility District financial report as submitted, MC.

#### Approval of Water Utility Invoices

Motion (McMahon, Johnson) to approve Water Utility District invoices in the amount of \$7,987.45, MC.

#### New and Unfinished Business – Discussion and possible action on all of the following:

#### Long-range Water Utility District feasibility and capacity study

Hanson stated that he wishes to have a study done to determine what costs would be incurred by the Water Utility District to drill a backup well to serve as a secondary water supply during any operational failures of the main well pump, such as what occurred this past summer. He noted that this study could also investigate what costs may be incurred if the Commission ever chose to dissolve the Water Utility District and merge it with the Racine Water Utility. He estimated that such a study would cost approximately \$10,000.00. The Commission authorized Hanson to contact Short Elliot Hendrickson to ask them to put together an agreement for such a study.

Hanson added that the Water Utility District would contribute up to \$250.00 to Spee-Dee for this maintenance.
