Call to Order

Water Utility District Commission President Peter Hansen called the meeting to order at 6:10 p.m.

Roll Call

The following Water Utility District Commission members were present: Peter Hansen, Sherry Gruhn and Thomas Johnson. Terrence McMahon and Lawrence Robers were absent. Also present were Engineer Mark Madsen, Water Utility District Manager Gary Hanson and Clerk-Treasurer Michael McKinney.

Approval of Minutes

Motion (Gruhn, Johnson) to approve the December 16, 2014 Water Utility District Commission meeting minutes as submitted, Motion Carried (MC).

He added that SEH would analyze future operational alternatives for the utility, such as making no changes, drilling a backup well to serve as a secondary water supply during any operational failures of the main well pump, purchasing water on a wholesale basis from the Racine Water Utility or selling its assets outright to the Racine Water Utility. He noted that the cost for this evaluation is \$8,900.00.
