## Call to Order

Water Utility District Commission President Peter Hansen called the meeting to order at 7:08 p.m.

#### SEH long-range feasibility and capacity study

Hansen noted that he met with the Racine Water Utility manager regarding this issue, adding that he was told that the Racine Water Utility would be open to purchasing and assuming control over the water utility's infrastructure if the Commission chose to pursue that option.

- That 8 hydrants have been damaged since late 2014
- That he identified an instance of water theft from the water utility on Monday, July 13
- That the facility located at 1520 Grandview Parkway does not have a water service bypass installed. He noted that he will contact this business to make them aware that a bypass should be installed to prevent service interruptions when their meter is serviced.
- That annual water testing for nitrates will be taking place in August

Engineer's Report - Madsen noted that he had no information to report to the Commission.

Clerk's Report - McKinney noted that he had no information to report to the Commission.
