Water Utility District Manager's Report - Hanson reported to the Commission on the following:

- That he will be reading water meters in March for the first quarter's commercial water billing cycle
- That he has ordered two meters with remote reader units
- That he is ordering Storz nozzle adapters for the ten hydrants that still remain to be retrofitted with the adapters, which will be completed in 2017
- That mildew needs to be cleaned from the water tower
- That he plans to delay painting hydrants until more progress is made on the Racine Water Utility's prospective offer to purchase the Yorkville Water Utility District
- That the truck wash that has been proposed for South Sylvania Avenue would use approximately 2,500 gallons of water per day, adding that the sewer lateral coming from this proposed facility would require a sampling manhole and a flow measuring flume as well as monitoring of pH levels in this facility's sewer discharge
