A RESOLUTION ADOPTING THE TOWN OF YORKVILLE'S 2017 PAYABLE 2018 PROPERTY TAX LEVY

THE ELECTORS OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVE AS FOLLOWS:

WHEREAS, the Yorkville Town Board and all subunit committees of the Town of Yorkville, through the budgeting process, are responsible for appropriating the funds necessary for the efficient and responsible operation of the government, administration and operation of the Town of Yorkville and all its subunits, and

WHEREAS, the Yorkville Town Board recommended, on September 28, 2017, that \$1,082,059.00 in property tax revenue be collected to help achieve these goals, and

WHEREAS, the Yorkville Water Utility Commission recommended, on October 17, 2017, pursuant to Wisconsin Statutes Section 196.03(3)(b) and in proportion to the 2017 assessed valuations of all properties in Yorkville Water Utility District No. 1, that \$91,950.00 in property tax revenue be collected to help achieve these goals, and

WHEREAS, the Yorkville Town Board held a public hearing on the proposed 2018 Town budget on November 15, 2017, and

WHEREAS, Wisconsin Statutes Section 60.10(1)(a) authorizes town electors to adopt a tax levy at a special town elector meeting, and

WHEREAS, a Special Town Elector Meeting has been called and noticed, pursuant to Wisconsin Statutes Section 60.12, on November 15, 2017, by the Town of Yorkville for this purpose.

NOW, THEREFORE, by majority vote of the eligible electors duly assembled and voting on November 15, 2017, at the Special Town Elector Meeting of the Town of Yorkville, Racine County, Wisconsin,

BE IT RESOLVED, that said electors hereby adopt a 2017 payable 2018 property tax levy in the amount of \$1,174,009.00, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to distribute said taxes upon the current tax roll of the Town of Yorkville, and


BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, as required by Wisconsin Statutes Section 60.80(1), and

BE IT FURTHER RESOLVED, that this resolution takes effect the day following its posting.

This Resolution was adopted by the Electors of the Town of Yorkville at a Special Town Elector Meeting on November 15, 2017.
