**TOWN OF YORKVILLE
RACINE COUNTY, WISCONSIN**

**A RESOLUTION ADOPTING THE TOWN OF YORKVILLE'S 2017
PAYABLE 2018 PROPERTY TAX LEVY AND 2018 BUDGETS**

**THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN,
RESOLVES AS FOLLOWS:**

WHEREAS, the Yorkville Town Board, per Section 46-121 of the Town of Yorkville Code of Ordinances, is responsible for preparing an annual budget for the efficient and responsible operation of the government, administration and operation of the Town of Yorkville, and

WHEREAS, the Yorkville Town Board recommended a 2018 annual General Fund budget to help achieve these goals on September 28, 2017, and

WHEREAS, the Yorkville Sewer Utility District Commission recommended a 2018 annual Sewer Utility Fund budget to help achieve these goals on October 17, 2017, and

WHEREAS, the Yorkville Water Utility District Commission recommended a 2018 annual Water Utility Fund budget to help achieve these goals on October 17, 2017, and

WHEREAS, the Yorkville Stormwater Utility District Commission recommended a 2018 annual Stormwater Utility Fund budget to help achieve these goals on October 5, 2017, and

WHEREAS, the Yorkville Town Board, after proper notice was given in accordance with Wisconsin Statutes 65.90(3)(a)(1), held a public hearing on the proposed 2018 annual budget for these four bodies on November 15, 2017, and

WHEREAS, the electors of the Town of Yorkville, by majority vote at a Special Town Elector Meeting on November 15, 2017, adopted a 2017 payable 2018 property tax levy in the amount of \$1,174,009.00.

NOW, THEREFORE, BE IT RESOLVED, that the Yorkville Town Board hereby adopts the 2018 Town annual General Fund budget in the amount of \$1,592,682.71, and

BE IT FURTHER RESOLVED, that the Yorkville Town Board hereby adopts the 2017 payable 2018 property tax levy in the amount of \$1,174,009.00 and authorizes and directs the Clerk-Treasurer to distribute the same upon the 2017 tax roll, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2017 tax roll against respective properties, pursuant to Wisconsin Statutes 66.0809(3), unpaid and delinquent sewer utility charges and penalties of Yorkville Sewer Utility District No. 1 in the amount of up to \$1,016.40, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2017 tax roll against respective properties, stormwater special assessment charges in the amount of up to \$55,028.00, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2017 tax roll, in proportion to the 2017 assessed valuations of the Town, the following tax levies:

1. Racine County – \$1,914,533.20
2. Racine County Children with Disabilities – \$82,409.19
3. Union Grove J1 Elementary School – \$506,389.95
4. Yorkville J2 Elementary School – \$3,297,094.00
5. Union Grove Union High School – \$1,993,357.84
6. Gateway Technical College – \$413,250.55, and

BE IT FURTHER RESOLVED, that the 2018 Yorkville Sewer Utility District No. 1 budget of \$411,245.84 be hereby adopted, and

BE IT FURTHER RESOLVED, that the 2018 Yorkville Water Utility District No. 1 budget of \$169,917.72 be hereby adopted, and

BE IT FURTHER RESOLVED, that the 2018 Yorkville Water Utility District No. 1 tax equivalency charge, created pursuant to Wisconsin Statutes 66.0811(2), be set at \$17,714.28, and

BE IT FURTHER RESOLVED, that the 2018 Yorkville Stormwater Utility District budget of \$66,090.00 be hereby adopted, and

BE IT FURTHER RESOLVED, that the 2018 Union Grove-Yorkville Fire Department budget of \$595,569.00 be hereby adopted, with Yorkville's share of said budget being \$207,118.00, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, as required by Wisconsin Statutes 60.80(1), and

BE IT FURTHER RESOLVED, that this resolution takes effect the day following its posting.

This Resolution was adopted by the Yorkville Town Board on November 15, 2017.
