**A RESOLUTION DESIGNATING AND APPOINTING COMMITTEE MEMBERS
AND OFFICIALS TO VARIOUS POSITIONS IN VILLAGE OF YORKVILLE GOVERNMENT**

**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN,
RESOLVES AS FOLLOWS:**

WHEREAS, the following appointment terms expire, effective April 30, 2018:

1. Weed Commissioner, 2-year term;
2. Building Inspector, 2-year term;
3. Electrical Inspector, 2-year term;
4. Plumbing Inspector, 2-year term;
5. Emergency Government Director, 2-year term;
6. Zoning Administrator, 2-year term;
7. Plan Commissioner, 3-year term;
8. Plan Commissioner, 3-year term;
9. Plan Commissioner (Village Board representative on the Plan Commission), 1-year term;
10. Plan Commissioner (Village Board representative on the Plan Commission), 1-year term;
11. Stormwater Commissioner, 5-year term;
12. Stormwater Commissioner (Village Board representative on the Stormwater Commission), 1-year term;
13. Stormwater Commissioner (Plan Commission representative on the Stormwater Commission), 1-year term;
14. Sewer Utility District Commissioner, 5-year term;
15. Water Utility District Commissioner, 5-year term;
16. Board of Review Member (Citizen representative), 3-year term;
17. Board of Review Member (Citizen representative – alternate), 3-year term;
18. Sex Offender Residency Appeals Board Member, 3-year term;
19. Sex Offender Residency Appeals Board Alternate Member, 3-year term, and

WHEREAS, Village of Yorkville Code of Ordinances Section 2-81 provides for the designation and appointment of all members of any standing and special committee established by the Village Board by the Village President, which shall be subject to confirmation by a majority vote of the Village Board, and

WHEREAS, Village of Yorkville Code of Ordinances Section 2-112 provides for the biennial designation and appointment of the following officers by the Village President for two-year terms, which shall be subject to confirmation by a majority vote of the Village Board:

1. Weed Commissioner;
2. Building Inspector;
3. Electrical Inspector;
4. Plumbing Inspector;
5. Emergency Government Director;
6. Zoning Administrator, and

WHEREAS, Village of Yorkville Code of Ordinances Section 2-202 provides for the staggered designation and appointment of citizen Plan Commissioner members for three-year terms, which shall be subject to confirmation by a majority vote of the Village Board, and

WHEREAS, Village of Yorkville Code of Ordinances Section 54-277 provides for the staggered designation and appointment of Yorkville Stormwater Utility District Commissioner members for five year terms, which shall be subject to confirmation by a majority vote of the Village Board.

NOW, THEREFORE, BE IT RESOLVED, that the Yorkville Village Board designates and appoints the following individuals to the following positions with terms of office to expire on the following dates:

7. Peter Hansen (Village Board representative on the Plan Commission), Plan Commissioner, April 30, 2019;
8. John Vyvyan, Stormwater Commissioner, April 30, 2023;
9. Sherry Gruhn (Village Board representative on the Stormwater Commission), Stormwater Commissioner, April 30, 2019;
10. Robbie Funk (Plan Commission representative on the Stormwater Commission), Stormwater Commissioner, April 30, 2019;
11. Leo DeBrabander, Sewer Utility District Commissioner, April 30, 2023;
12. Leo DeBrabander, Water Utility District Commissioner, April 30, 2023;
13. Marjorie Martin, Sex Offender Residency Appeals Board Member, April 30, 2021, and

BE IT FURTHER RESOLVED, that each of these new appointment terms shall begin on May 1, 2018, and

BE IT FURTHER RESOLVED, that no appointments be made to the positions of Emergency Government Director and Zoning Administrator at this time, and

BE IT FURTHER RESOLVED, that no appointment be made to the position of Plan Commissioner until such time as a suitable candidate is identified, and

BE IT FURTHER RESOLVED, that no appointment be made to the position of citizen representative on the Board of Review until such time as a suitable candidate is identified, and

BE IT FURTHER RESOLVED, that no appointment be made to the position of citizen representative on the Board of Review - alternate until such time as a suitable candidate is identified, and

BE IT FURTHER RESOLVED, that no appointment be made to the currently vacant position of Stormwater Commissioner, with said appointment expiring on April 30, 2022, until such time as a suitable candidate is identified, and

BE IT FURTHER RESOLVED, that no appointment be made to the currently vacant position of Sewer Utility District Commissioner, with said appointment expiring on April 30, 2022, until such time as a suitable candidate is identified, and

BE IT FURTHER RESOLVED, that no appointment be made to the currently vacant position of Water Utility District Commissioner, with said appointment expiring on April 30, 2022, until such time as a suitable candidate is identified, and

BE IT FURTHER RESOLVED, that no appointment be made to the currently vacant position of Sex Offender Residency Appeals Board Alternate Member, with said appointment expiring on April 30, 2021, until such time as a suitable candidate is identified, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, and

BE IT FURTHER RESOLVED, that this resolution takes effect the day following its posting.
