**A RESOLUTION TO DESIGNATE AND APPOINT BOARD, COMMISSION AND
COMMITTEE MEMBERS TO VARIOUS APPOINTED BODIES WITHIN VILLAGE OF
YORKVILLE GOVERNMENT**

**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY,
WISCONSIN, RESOLVES AS FOLLOWS:**

WHEREAS, Village of Yorkville Code of Ordinances Section 2-81 provides for the designation and appointment of all members of any standing and special committee established by the Village Board by the Village President, which shall be subject to confirmation by a majority vote of the Village Board, and

WHEREAS, Village of Yorkville Code of Ordinances Section 54-277 provides for the staggered designation and appointment of Yorkville Stormwater Utility District Commissioner members for five-year terms, which shall be subject to confirmation by a majority vote of the Village Board, and

WHEREAS, Village of Yorkville Code of Ordinances Section 55-2 provides for the initial designation and appointment of five citizen members of the Yorkville Board of Appeals to staggered terms of one, two or three years and of two alternate members of the Yorkville Board of Appeals to staggered terms of three years by the Village President, which shall be subject to confirmation by a majority vote of the Village Board.

NOW, THEREFORE, BE IT RESOLVED, that the Yorkville Village Board designates and appoints the following individuals to the following positions with terms of office to expire on the following dates:

1. Michael DeGarmo, Board of Appeals member, April 30, 2020;
2. Dennis Lee, Board of Appeals member, April 30, 2019;
3. Martin Winter, Board of Appeals member, April 30, 2020;
4. Sherry Gruhn (Plan Commission representative on the Stormwater Utility District Commission), Stormwater Utility District Commissioner, April 30, 2019;
5. Clinton Funk, Stormwater Commissioner, April 30, 2020;
6. Timothy DeGarmo, Long-Range Planning/Ordinance Committee member, April 30, 2019;
7. Tom Gehrand, Long-Range Planning/Ordinance Committee member, April 30, 2019;
8. Daniel Maurice, Long-Range Planning/Ordinance Committee member, April 30, 2019;
9. Terrence McMahon, Long-Range Planning/Ordinance Committee member, April 30, 2019, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, and

BE IT FURTHER RESOLVED, that this resolution takes effect the day following its posting.
