- 3. Sherry Gruhn (Village Board representative on the Yorkville Sewer and Water Commission), Yorkville Sewer and Water Commissioner, April 30, 2019:
- 4. Daniel Maurice, (Village Board representative on the Yorkville Sewer and Water Commission), Yorkville Sewer and Water Commissioner, April 30, 2019;
- 5. Steve Nelson (Village Board representative on the Yorkville Sewer and Water Commission), Yorkville Sewer and Water Commissioner, April 30, 2019, and

**BE IT FURTHER RESOLVED,** that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, and

BE IT FURTHER RESOLVED, that this resolution takes effect the day following its posting.
