

ORDINANCE NO. 2019-02

AN ORDINANCE TO AMEND DIVISION 4, SECTION 2-231 OF THE CODE OF ORDINANCES OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN RELATED TO THE MEMBERSHIP OF THE BOARD OF REVIEW AND DELETING REFERENCES RELATED TO TOWN

THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

1. That Division 4, Section 2-231 of the Code of Ordinances for the Village of Yorkville be, and hereby is, amended to read as follows:

“Division 4. Board of Review

Sec. 2-231. Membership.

The board of review of the village shall consist of the village president, village clerk-treasurer, village trustees, a resident of the village to be appointed by the village board for a term of three years, and one or more alternate members who are residents of the village. Alternate members shall serve on the board of review when standing members are removed from individual cases. Alternate members of the board of review are to be appointed by the village board, and shall serve for a term of three years. The village assessor shall not be a member of the board of review.”

2. That any references to “town” in Division 4 of the Code of Ordinances for the Village of Yorkville be, and hereby is, amended to read as “village”.

3. That this ordinance shall become effective upon adoption and publication as provided by law.
