**WHEREAS**, Village of Yorkville Code of Ordinances Section 2-81 provides for the designation and appointment of all members of any standing and special committee established by the Village Board by the Village President, which shall be subject to confirmation by a majority vote of the Village Board, and

**WHEREAS**, Village of Yorkville Code of Ordinances Section 2-112 provides for the biennial designation and appointment of the following officers by the Village President for two-year terms, which shall be subject to confirmation by a majority vote of the Village Board:

1. Emergency Government Director;

**WHEREAS**, Village of Yorkville Code of Ordinances Section 2-202 provides for the staggered designation and appointment of citizen Plan Commissioner members for three-year terms by the Village President, which shall be subject to confirmation by a majority vote of the Village Board, and

**WHEREAS**, Village of Yorkville Code of Ordinances Section 2-231 provides for the staggered designation and appointment of citizen Board of Review alternate members for three-year terms by the Village President, which shall be subject to confirmation by a majority vote of the Village Board, and

**WHEREAS**, Village of Yorkville Code of Ordinances Section 30-130(j)(2) provides for the staggered designation and appointment of Sex Offender Residency Appeals Board members for three-year terms and a Sex Offender Residency Appeals Board alternate member for a three-year term by the Village Board Chairperson, which shall be subject to confirmation by a majority vote of the Village Board.

**WHEREAS**, Village of Yorkville Code of Ordinances Section 54-277 provides for the staggered designation and appointment of citizen Yorkville Stormwater Utility District Commission members for five-year terms by the Village President, which shall be subject to confirmation by a majority vote of the Village Board, and

**WHEREAS**, Village of Yorkville Code of Ordinances Section 55-2 provides for the staggered designation and appointment of Yorkville Board of Appeals members for three-year terms and alternate Yorkville Board of Appeals members for three-year terms by the Village President, which shall be subject to confirmation by a majority vote of the Village Board, and

**BE IT FURTHER RESOLVED**, that no appointment be made to the position of Board of Review alternate citizen member until such time as a suitable candidate is identified, and

**BE IT FURTHER RESOLVED**, that no appointment be made to the currently vacant position of Board of Appeals alternate member, with said appointment expiring on April 30, 2021, until such time as a suitable candidate is identified, and

**BE IT FURTHER RESOLVED**, that no appointment be made to the currently vacant position of Sex Offender Residency Appeals Board alternate member, with said appointment expiring on April 30, 2021, until such time as a suitable candidate is identified, and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, and

**BE IT FURTHER RESOLVED**, that this resolution takes effect the day following its posting.


