**VILLAGE OF YORKVILLE  
RACINE COUNTY, WISCONSIN**

**A RESOLUTION AUTHORIZING THE PURCHASE OF A FIRE TRUCK FOR THE UNION  
GROVE-YORKVILLE FIRE DEPARTMENT**

**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN,  
RESOLVES AS FOLLOWS:**

**WHEREAS**, the then Town (now Village) of Yorkville and the Village of Union Grove entered into an agreement dated July 31, 1973, and amended March 8, 1995, for the continuation and improvement of fire and rescue services to the areas served for both municipalities by the Union Grove-Yorkville Fire Department and such agreement established rules and procedures governing fire and rescue equipment, motor vehicles, and real property, and the purchase thereof (the "Agreement"), and

**WHEREAS**, from time-to-time, either Village will agree to borrow funds to pay for fire and rescue equipment, motor vehicles, and real property for the Union Grove-Yorkville Fire Department, and each Village will share proportionally in the repayment of the debt in accordance with the Agreement, and

**WHEREAS**, when either Village borrows funds, the loan payments are made directly by the Union Grove-Yorkville Fire Department and the Union Grove-Yorkville Fire Department budgets for such payment and such budget is supported proportionately by each Village in accordance with the Agreement, and

**WHEREAS**, the Union Grove-Yorkville Fire Department has requested that the Village of Union Grove borrow an amount not to exceed \$725,000.00 to pay for the purchase of a fire truck, and

**WHEREAS**, the Village of Union Grove adopted Resolution No. 2020-09 authorizing the submission of an application to the Board of Commissioners of Public Lands of Wisconsin to request a General Obligation Loan in an amount not to exceed \$725,000.00 for this purpose, and

**WHEREAS**, the Village of Union Grove is prepared to incur this debt based on the repayment of the debt occurring in accordance with the Agreement, with the Village of Yorkville being responsible for its share in accordance with the Agreement.

**NOW, THEREFORE, BE IT RESOLVED**, by the Village Board of the Village of Yorkville, Racine County, Wisconsin, that the Village of Yorkville hereby adopts this resolution acknowledging this loan application and authorizing the repayment of this loan in accordance with the Agreement, and

**BE IT FURTHER RESOLVED**, that the Administrator/Clerk is hereby directed to post this resolution in three places within thirty days of its adoption, and

**BE IT FURTHER RESOLVED**, that this resolution takes effect the day following its posting.

This Resolution was adopted by the Yorkville Village Board on May 11, 2020.




