Sewer Utility District Manager's Report - Hanson reported to the Commission on the following:

- That the Wisconsin Department of Natural Resources approved the utility's effluent toxicity plan, with an implementation date of October 1
- That the utility's facilities plan document has been submitted to the Wisconsin Department of Natural Resources
- That the utility's proposed compliance dates for its newest discharge permit have been approved by the Wisconsin Department of Natural Resources
- That the Southeastern Wisconsin Regional Planning Commission will be considering the utility's proposed sewer service area amendment tomorrow
- That one of the new sampling manholes on the property located at 14015 Grandview Parkway was damaged and had asphalt pushed into it

Water Utility District Manager's Report - Hanson reported to the Commission on the following:

- That he will begin reading water meters tomorrow
- That he flushed hydrants last week
- That he received a new water meter for the customer located at 820 South Sylvania Avenue, which will be installed in the next month
- That a gate valve was damaged last week due to the Washington Avenue (STH 20) reconstruction project
- That he continues to work with Racine County on the proposed purchase of a portion of the parcel located immediately to the northwest of the existing water tower site

Engineer's Report - Madsen stated that his office is currently working on the annual commercial sewer user charge updates.

Administrator/Clerk's Report - McKinney stated that quarterly sewer and water utility bills will be mailed at the end of the month.
