- Include a certificate of liability insurance showing evidence of fireworks liability, for the payment of all claims that may arise by reason of injuries to person or property from the handling, use or discharge of fireworks, in the amount of no less than \$1,000,000, with the Village of Yorkville named as an additional insured.

By signing this application, the undersigned agrees to the following:

- That no fireworks shall be used or displayed that are prohibited by the State of Wisconsin.
- That no fireworks shall be sold or purchased within Village limits.
- That fireworks shall not be used before dusk or after 11:00 p.m., unless otherwise approved by the Village Board.
- That the applicant shall obtain the consent of the property owner of the described property prior to displaying fireworks there.
- That only the applicant or their designee can use or display fireworks at the above-described property under this permit.
- That this permit may be cancelled and rescheduled by the Village if the weather or other situations make it unsafe to display fireworks or if the Village Board determines that the permit was issued based upon fraud or misrepresentation.
- That this permit is not a guarantee by the Village or any of its officers or designees that the use of fireworks is safe.
- That the applicant hereby indemnifies the Village for all claims related to the use of fireworks.
