Call to Order

Village Board President Douglas Nelson called the meeting to order at 6:00 p.m.

Roll Call

The following Village Board members were present: Douglas Nelson, Robert Funk, Daniel Maurice, Steve Nelson and Cory Bartlett. The following Plan Commission members were present: Douglas Nelson, Cory Bartlett, Barbara Geschke, Aaron Alby and Timothy DeGarmo. Also present were Engineer Mark Madsen and Administrator/Clerk Michael McKinney.

Motion (S. Nelson, Funk) to approve the March 22, 2021 Village Board meeting minutes as presented, Motion Carried (MC).

18917 Spring Street (CTH C) property maintenance

Discussion focused on the outstanding violations related to this property and the steps necessary to immediately pursue enforcement of those violations.

58th Road and Braun Road weight limits

Discussion focused on whether weight limits on 58th Road and Braun Road should be temporarily lowered to prevent heavier vehicles from using either road as a detour route during the repaying and reconstruction of Durand Avenue (STH 11).

Application submitted by WE Energies for a permit to open Kingston Way for the purposes of installing new natural gas service for the property located at 15130 Kingston Way

Engineer's Report - report on activities and issues

Madsen reported to the Village Board on the following:

- That the repaving of 55th Drive is underway
- That the small hump found last year on the newly paved portion of 67th Drive remains
- The he was contacted by a potential developer about the Village's pond requirements

Discussion also focused on drainage issues in the Stonecrest Shores subdivision and on Leetsbir Road.

2848 Twin Waters Lane property maintenance and inspection

McKinney stated that, while the property owner told him in December that she would apply for a permit to raze the home, no such permit has been applied for. He added that there was apparently interest from another party to purchase the home, but that sale did not materialize.

Motion (Maurice, Bartlett) to do the following:

- To authorize the Administrator/Clerk to send a letter to the owner of the property located at 2848 Twin Waters Lane requesting that the Village's building inspector be permitted to perform an inspection of the home located on the property within ten days to ascertain whether the condition of the home is such that it should be razed; and
- To authorize the Village Attorney to obtain a special inspection warrant from the Municipal Judge to gain access to the property if the letter requesting access to the property is ignored or refused, MC.

Stafford Rosenbaum/Racine County Drainage Board of Commissioners request for informed consent

McKinney stated that approval of this request would allow Stafford Rosenbaum, who represented Yorkville in various matters in the past, to represent the Racine County Drainage Board of Commissioners in their negotiation of a new stormwater maintenance and assessment agreement with Yorkville.

- That bidding is open for the wastewater treatment facility expansion project, with a bid opening scheduled for May 14
- That a final recommendation has yet to be made on the two submitted building inspection services proposals
- That the owner of the property located at 17806 Spring Street (CTH C) has yet to be served the raze order taken out on this property because he cannot be located
- That a tentative settlement has been reached in the small claims case involving Yorkville and the owner of the property located at 2209 South Colony Avenue (USH 45)

Maurice stated that dump trucks are being parked again on the property located at 18108 Spring Street (CTH C). He asked about the status of the letter sent to Racine County requesting that the County rescind the balance owed to them by Yorkville for expenses incurred by the Village and reimbursed by Racine County in 2017-2018 stemming from the Foxconn project.
