Call to Order

Village Board President Douglas Nelson called the meeting to order at 6:01 p.m.

Roll Call

The following Village Board members were present: Douglas Nelson, Robert Funk, Daniel Maurice, Steve Nelson and Cory Bartlett. Also present were Assessor Jim Henke, Plan Commissioner Barbara Geschke, Alan Geschke, Code Enforcement Officer Terrence O'Brien and Administrator/Clerk Michael McKinney.

Approval of Minutes

Motion (Funk, S. Nelson) to approve the May 10, 2021 joint Village Board/Plan Commission meeting minutes as presented, Motion Carried (MC).

Approval of Village Invoices

Motion (Maurice, Bartlett) to approve payment of Village invoices as presented in the amount of \$34,702.65, MC.

Approval of Stormwater Invoices

Motion (Funk, Maurice) to approve payment of Stormwater invoices as presented in the amount of \$18.75, MC.

New and Unfinished Business - Discussion and possible action on the following:

2021 property assessment update

Henke stated that his estimate of the overall assessment roll increase for Yorkville is approximately 28%, adding that the overall residential assessment roll will increase by approximately 25%. He noted that assessment notices will be mailed out within the next week.

No formal action was taken by the Village Board on this agenda item.

2021 55th Drive paving and drainage program project

Discussion focused on the progress of this project as well as some of the concerns that have been identified during the paving process, including issues related to the delay in laying down a second course of asphalt on the road.

No formal action was taken by the Village Board on this agenda item.

2021 road maintenance projects

Discussion focused on a proposed road maintenance project and expenditure plan recommended by the Roads/Public Works Committee for projects in 2021, including the following from the Village's road maintenance or construction budgets:

- \$18,000 to cover any additional engineering expenses related to the 55th Drive paving and drainage program project (from construction)
- \$20,000 for any additional snowplowing or ice control in 2021 (from maintenance)
- \$30,000 for crack filling
- \$20,000 for drain tile repairs
- \$60,000 for road shoulder repairs
- \$6,000 for North Colony Avenue riprap and ditch repairs
- The remaining approximately \$35,000 set aside as a contingency for any emergency repairs (from maintenance)

Motion (S. Nelson, Funk) to authorize the Roads/Public Works Committee to proceed with the 2021 road maintenance project and expenditure plan as proposed to the Village Board, MC.

2022-2027 Wisconsin Department of Transportation Local Bridge Program

Discussion focused on applying for funding under this program for replacement of the 2 Mile Road bridge over the East Branch of the Root River Canal and whether a second application could be submitted for rehabilitation or replacement of the 50th Road bridge over the West Branch of the Root River Canal.

Motion (Bartlett, S. Nelson) to authorize the Village Engineer to prepare an application for the Wisconsin Department of Transportation's 2022-2027 Local Bridge Improvement Program for reimbursement of future design and construction costs to replace the 2 Mile Road bridge over the East Branch of the Root River Canal, MC.

Engineer's Report - report on activities and issues

The Engineer was not present to provide a report to the Village Board.

No formal action was taken by the Village Board on this agenda item.

2020 annual audit report

McKinney presented the 2020 audit report for the Village of Yorkville, the Yorkville Sewer Utility District, the Yorkville Water Utility District, and the Yorkville Stormwater Utility District to the Village Board. He stated that the Village's fund balance increased by \$331,763 in 2020 to \$1,288,657.

Motion (S. Nelson, Maurice) to adopt the 2020 annual audit as presented, MC.

American Rescue Plan Act fund distribution

Discussion focused on how to distribute funds received under the American Rescue Plan Act, including the dedication of funds towards wastewater treatment plant improvements, fire- or EMS-related expenditures, or broadband access improvements.

No formal action was taken by the Village Board on this agenda item.

Motion (S. Nelson, Maurice) to grant a Special Event Permit to Julia Mors on behalf of Amcan Truck Parts for the Amcan Truck Fest, to be held at the Racine County Fairgrounds, 19805 Durand Avenue (STH 11), from Friday, June 11, 2021 to Saturday, June 12, 2021, with no conditions, MC.
