

REPORT/COVER LETTER FOR CUP APPLICATION AT 14114 LEESTBIR ROAD

Dear Staff,

Enclosed below is description of the proposed Use relating to the property at 14114 Leesbir Road, in the Village of Yorkville/Racine County.

A. Existing & Proposed Land Use

The current zoning for 14114 Leetsbir Road, Yorkville is Heavy Industrial. We would like to apply for a Conditional Use utilizing the existing warehouse building on the property. Stericycle has leased a portion this property from Darnell Family Limited Partnership since 1998.

The Stericycle plant located at 14035 Leetsbir Road in Yorkville, WI and operating under WI DNR License # 3350 is replacing old material handling equipment and outgrowing our current building located on the western part of the property. We are looking to move into a larger area and new equipment at 14114 Leetsbir Road in Yorkville. This address is due north of our current location but across the road. The function of the new equipment will be the same as the old equipment, that is, to remove the lids from sharps containers, dump the contents, and pre-clean the containers before placement into the washer for final cleaning and sanitization. The waste would then be transferred to the 14035 Leetsbir Road address for treatment.

This new process equipment will replace existing equipment that has been in service for nearly 20 years and will greatly enhance safety and efficiency.

In addition, we have similar program we would like to implement at 14114 Leetsbir Road that involves a comingled program. This program that uses one container for sharps and nonhazardous pharmaceuticals making it more efficient for nursing staff after administering. These containers are blue in color and would be brought to 14114 Leetsbir Road and handled as the red containers are. One exception is the waste could not be treated at 14035 Leetsbir Road but would be sent to one of our incinerators due to the nonhazardous pharmaceuticals. Attached is an informational sheet on this program.

We have received approval from the Wisconsin DNR for both projects and they have modified our current permit to include the new address of 14114 Leetsbir Road, Yorkville, WI.

B. Existing & Proposed Structure(s) Type & Color

The existing building is metal and light tan in color. There are 4 overhead dock doors on the lower level with an office and restrooms. The upper level is a single floor type warehouse. No changes are being made to the facility.

C. Number of employees (part time & full time)

We will be starting out with 20 employees.



D. Hours/Days of Operation

Days of operation will be Monday to Friday; Times will need to be determined on the new equipment efficiency, expected to be between the hours of 7:00AM-5:00PM, subject to final installation.

E. Construction Start & Completion Time Schedule

We have installed some of the new equipment inside the warehouse as this equipment is custom built. Once the CUP is approved we have contractors that would need to submit permits to complete the installation and electrical.

F. Sewered or Unsewered Development

Leetsbir Road does not have sewer lines. Currently at our existing location all process water in each building is pumped into above ground storage tanks and hauled away to Racine County wastewater treatment. We have an industrial wastewater discharge permit with them that expires on December 31, 2024.

In our proposed location we would do the same of pumping the wastewater from the washing process into an above ground storage tank. We currently contract with Pat's to haul the water to Racine County wastewater treatment.


