A RESOLUTION APPROVING ROADWAY CLASSIFICATION CHANGES
IN THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN

THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN,
RESOLVES AS FOLLOWS:

WHEREAS, the Wisconsin Department of Transportation conducts periodic reviews and updates to the functional classification system of roadways across the state of Wisconsin; and

WHEREAS, the Federal Highway Administration has issued guidance related to the development of functional classification of roadways; and

WHEREAS, the Wisconsin Department of Transportation has submitted recommended changes to the functional classification system of roadways in the Village of Yorkville; and

WHEREAS, the changes proposed to the functional classification system of streets in the Village of Yorkville are shown in the roadway functional classification system change list, as shown in Exhibit A to this Resolution; and

WHEREAS, after Village Engineer and staff review, the proposed classification changes have been found to be justified.

NOW, THEREFORE, BE IT RESOLVED, by the Village Board of the Village of Yorkville, Racine County, Wisconsin, that the Village informs the Wisconsin Department of Transportation that the roadway functional classification system changes as outlined in the change list, as shown in Exhibit A of this Resolution, are approved and that the above actions were taken by the Village Board of the Village of Yorkville.

This Resolution was adopted by the Yorkville Village Board on October 24, 2022.

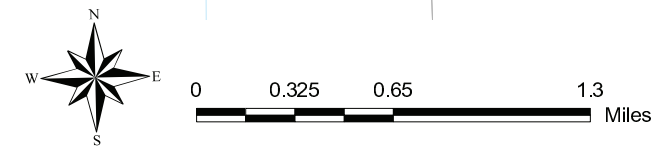
