Discussion focused on Condition #24 of this resolution, relating to the submission of a complete site grading plan, erosion control plan and stormwater management plan for review and approval by the Village Engineer. McKinney stated that recent grading has taken place on this property, adding that the location of existing disturbed areas of the property cannot be determined because of this grading. Madsen stated that he cannot determine whether there will be sufficient disturbance on this property related to this use to trigger this condition. He

recommended that the Village Board amend this condition to require that the complete site grading plan, erosion control plan and stormwater management plan be presented for his review and approval as part of a comprehensive development plan when the remainder of the property is set for development.

"24. <u>Plans Required.</u> The applicant shall submit a comprehensive site grading plan, erosion control plan and stormwater management plan for the entire subject parcel meeting Village requirements for review and approval by the Village Engineer at the applicant's expense.", MC.
