**VILLAGE OF YORKVILLE
RACINE COUNTY, WISCONSIN**

**A RESOLUTION PERMITTING THE OPERATION OF SNOWMOBILES ON VILLAGE-OWNED
PROPERTY LOCATED AT 19040 SPRING STREET (CTH C)**

**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN,
RESOLVES AS FOLLOWS:**

WHEREAS, the Grove SnoHawk snowmobile club submitted a request to relocate a snowmobile trail to cross the Village-owned property located at 19040 Spring Street (CTH C) (Parcel ID # 194-03-21-20-016-000), and

WHEREAS, the location of this proposed snowmobile trail would be on a north-south axis immediately to the east of the Village's waste and recycling collection site on this same property, as depicted on the map attached as Exhibit A, and

WHEREAS, the Village's property and liability insurance provider raised no objections or concerns to the location of this proposed snowmobile trail.

NOW, THEREFORE, BE IT RESOLVED, by the Yorkville Village Board that the Village Board hereby designates the snowmobile trail as depicted on the map attached as Exhibit A, and

BE IT FURTHER RESOLVED, that the designation of this snowmobile trail is subject to the following conditions:

1. The Grove SnoHawk snowmobile club shall groom and maintain this trail
2. The Grove SnoHawk snowmobile club shall be responsible for all trail signage and marking, including at the Spring Street (CTH C) crossing
3. The Grove SnoHawk snowmobile club's trail grooming and maintenance equipment shall not drag snow, ice, or other materials onto Spring Street (CTH C)'s driving lanes or shoulder surface
4. Vehicular access to this trail shall be limited to snowmobiles and trail grooming and maintenance equipment
5. Any damages to Village property resulting from this use shall be repaired or restored to its original state as soon as practicable
6. Vehicles using this snowmobile trail shall not impede access to the Village's waste and recycling collection site
7. The Grove SnoHawk snowmobile club shall provide a current certificate of liability insurance to the Village prior to any use of this trail
8. The Grove SnoHawk snowmobile club shall obtain all authorizations and approvals from private property owners and public entities prior to the use of this snowmobile trail
9. All parties using this snowmobile trail shall adhere to the standards of operation established by Wis. Stats. Ch. 350 and the Wisconsin Department of Natural Resources
10. The maximum speed limit for all users of this trail shall be 25 (twenty-five) miles per hour and shall be posted as such by the Grove SnoHawk snowmobile club
11. This trail designation shall expire on April 30, 2023, and

BE IT FURTHER RESOLVED, that this trail may be reviewed for designation as a snowmobile trail on an annual basis at the request of the Grove SnoHawk snowmobile club, which shall submit a written request for trail designation to the Administrator/Clerk no later than October 1 of any year in which the trail designation is sought, and

BE IT FURTHER RESOLVED, that the Administrator/Clerk is hereby directed to send a copy of this resolution to the Wisconsin Department of Natural Resources, the Racine County Sheriff's Department, and the Union Grove-Yorkville Fire Department.

This Resolution was adopted by the Yorkville Village Board on November 14, 2022.
