A RESOLUTION AMENDING THE VILLAGE OF YORKVILLE'S 2022 GENERAL FUND
ANNUAL BUDGET

THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY,
WISCONSIN, RESOLVES AS FOLLOWS:

WHEREAS, the Village of Yorkville's 2022 General Fund annual budget was approved by the Yorkville Village Board on November 22, 2021, and

WHEREAS, this budget has individual line items where expenditures currently exceed the line item expenditures previously approved by the Yorkville Village Board, and

WHEREAS, Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and

WHEREAS, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body.

NOW, THEREFORE, BE IT RESOLVED, that the Yorkville Village Board hereby amends the 2022 Village of Yorkville General Fund annual budget with the transfers attached hereto as Exhibit "A", and

BE IT FURTHER RESOLVED, that the Treasurer is hereby directed to make the budgetary amendments described above, and



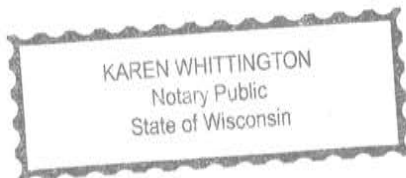
