**A RESOLUTION AMENDING THE VILLAGE OF YORKVILLE'S 2022 SEWER UTILITY
FUND AND WATER UTILITY FUND ANNUAL BUDGETS**

**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY,
WISCONSIN, RESOLVES AS FOLLOWS:**

WHEREAS, the Village of Yorkville's 2022 Sewer Utility Fund annual budget was approved by the Yorkville Sewer and Water Commission on October 19, 2021, and

WHEREAS, the Village of Yorkville's 2022 Sewer Utility Fund annual budget was approved by the Yorkville Village Board on November 22, 2021, and

WHEREAS, the Village of Yorkville's 2022 Water Utility Fund annual budget was approved by the Yorkville Sewer and Water Commission on October 19, 2021, and

WHEREAS, the Village of Yorkville's 2022 Water Utility Fund annual budget was approved by the Yorkville Village Board on November 22, 2021, and

WHEREAS, these budgets have individual line items where expenditures currently exceed the line item expenditures previously approved by the Yorkville Sewer and Water Commission and the Yorkville Village Board, and

WHEREAS, Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and

WHEREAS, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body.

NOW, THEREFORE, BE IT RESOLVED, that the Yorkville Village Board hereby amends the Village of Yorkville's 2022 Sewer Utility Fund annual budget with the transfers attached hereto as Exhibit "A", and

BE IT FURTHER RESOLVED, that the Yorkville Village Board hereby amends the Village of Yorkville's 2022 Water Utility Fund annual budget with the transfers attached hereto as Exhibit "B", and

BE IT FURTHER RESOLVED, that the Treasurer is hereby directed to make the budgetary amendments described above, upon approval of these same amendments by the Yorkville Sewer and Water Commission, and

BE IT FURTHER RESOLVED, that the Administrator/Clerk is hereby directed to publish a summary of this resolution, as required by Village of Yorkville Code of Ordinances Section 46-

126, upon approval of these same amendments by the Yorkville Sewer and Water Commission, and

BE IT FURTHER RESOLVED, that this resolution takes effect upon its publication.

This Resolution was adopted by the Yorkville Village Board on February 27, 2023.



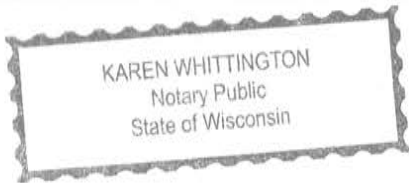
