

**RESOLUTION NO. 07-2014**

**TOWN OF YORKVILLE  
RACINE COUNTY, WISCONSIN**

**A RESOLUTION AMENDING THE TOWN OF  
YORKVILLE'S 2014 GENERAL FUND ANNUAL BUDGET**

**RECITALS:**

**WHEREAS**, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body, and

**WHEREAS**, the Town's 2014 General Fund annual budget was approved by the Yorkville Town Board on November 18, 2013, and

**WHEREAS**, this budget has individual line item expenditures that do or are likely to exceed those originally approved by the Town Board, and

**WHEREAS**, the Electors of the Town of Yorkville approved Resolution 04-2014 at the Annual Town Elector Meeting on April 15, 2014, which proposed an increase in highway expenditures in the Town's 2014 General Fund annual budget of \$288,500.80, from \$696,385.00 to \$984,885.80, and

**WHEREAS**, the Yorkville Town Board approved Resolution 06-2014 on May 12, 2014, which affirmed a motion made, seconded and approved by the Electors of the Town of Yorkville at the Annual Town Elector Meeting on April 12, 2011, to, if necessary, appropriate funds from the Local Government Investment Pool's Town Hall Building Account for road construction or maintenance purposes, and

**WHEREAS**, the December 31, 2013, cash reserve balance for the Town of Yorkville's General Fund showed an increase of \$219,843.00, from \$437,919.00 to \$657,762.00, which places the fund balance approximately \$424,511.94 above the 16.66% standard (two-month) reserve of \$233,250.06, and

**WHEREAS**, the Yorkville Town Board deems it necessary to draw funds in the amount of \$219,843.00 from the Town of Yorkville's General Fund cash reserve balance and in the amount of \$68,657.80 from the Local Government Investment Pool's Town Hall Building Account to help fund increased 2014 highway expenditures.

**NOW, THEREFORE, BE IT RESOLVED**, that the Yorkville Town Board amends the 2014 Town of Yorkville General Fund annual budget with the following transfers:

- \$68,657.80 from the Local Government Investment Pool's Town Hall Building Account to Road Construction, and
- \$135,568.00 from the Town of Yorkville's General Fund Cash Reserves to Highway Construction, and
- \$80,000.00 from the Town of Yorkville's General Fund Cash Reserves to Snow Removal and Sanding, and
- \$1,775.00 from the Town of Yorkville's General Fund Cash Reserves to Bridge Inspection, and
- \$2,500.00 from the Town of Yorkville's General Fund Cash Reserves to Street Lighting, and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to make the budgetary amendments described above, and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to transfer \$68,657.80 from the Local Government Investment Pool's Town Hall Building Account to the Local Government Investment Pool's General Account, and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to publish a summary of this resolution, as required by Town of Yorkville Code of Ordinances Section 46-126, and

**BE IT FURTHER RESOLVED**, that this resolution takes effect upon its publication.

This Resolution was adopted by the Yorkville Town Board on May 12, 2014.




