# TOWN OF YORKVILLE RACINE COUNTY, WISCONSIN

## A RESOLUTION AMENDING THE TOWN OF YORKVILLE'S 2015 GENERAL FUND, SEWER UTILITY FUND AND WATER UTILITY FUND ANNUAL BUDGETS

THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVES AS FOLLOWS:

**WHEREAS**, the Town of Yorkville's 2015 Sewer Utility Fund annual budget was approved by the Town of Yorkville Sewer Utility District Commission on October 21, 2014, and

WHEREAS, the Town of Yorkville's 2015 Water Utility Fund annual budget was approved by the Town of Yorkville Water Utility District Commission on October 21, 2014, and

**WHEREAS**, the Town of Yorkville's 2015 Sewer Utility Fund and Water Utility Fund annual budgets were both approved by the Yorkville Town Board on November 17, 2014, and

**WHEREAS**, the Town of Yorkville's 2015 General Fund annual budget was approved by the Yorkville Town Board on November 17 2014, and

**WHEREAS**, these budgets have individual line items where expenditures currently exceed the line item expenditures previously approved by the Town of Yorkville Sewer Utility District Commission, the Town of Yorkville Water Utility District Commission and the Yorkville Town Board, and

**WHEREAS**, Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and

**WHEREAS**, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body, and

**WHEREAS**, the Town of Yorkville Sewer Utility District Commission recommended, at their meetings on August 18, 2015, December 15, 2015, and January 19, 2016, that the 2015 Sewer Utility Fund annual budget be amended with the transfers included within and attached hereto as Exhibits "A", "C" and "D", and

**WHEREAS,** the Town of Yorkville Water Utility District Commission recommended, at their meetings on November 17, 2015, and January 19, 2016, that the 2015 Water Utility Fund annual budget be amended with the transfers included within and attached hereto as Exhibits "B" and "E".

**NOW, THEREFORE, BE IT RESOLVED,** that the Yorkville Town Board hereby amends the 2015 Town of Yorkville Sewer Utility Fund annual budget with the transfers attached hereto as Exhibits "A", "C" and "D", based upon the recommendations made by the Town of Yorkville Sewer Utility District Commission at their meetings on August 18, 2015, December 15, 2015, and January 19, 2016, and

**BE IT FURTHER RESOLVED,** that the Yorkville Town Board hereby amends the 2015 Town of Yorkville Water Utility Fund annual budget with the transfers attached hereto as Exhibits "B" and "E", based upon the recommendations made above by the Town of Yorkville Water Utility District Commission at their meetings on November 17, 2015, and January 19, 2016, and

**BE IT FURTHER RESOLVED,** that the Yorkville Town Board amends the 2015 Town of Yorkville General Fund annual budget with the transfers attached hereto as Exhibit "F", and

**BE IT FURTHER RESOLVED,** that the Clerk-Treasurer is hereby directed to make the budgetary amendments described above, and

**BE IT FURTHER RESOLVED,** that the Clerk-Treasurer is hereby directed to publish a summary of this resolution, as required by Town of Yorkville Code of Ordinances Section 46-126, and

TOWN OF VORKVILLE

BE IT FURTHER RESOLVED, that this resolution takes effect upon its publication.
