A RESOLUTION AMENDING THE TOWN OF YORKVILLE'S  
2015 GENERAL FUND ANNUAL BUDGET

THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN,  
RESOLVES AS FOLLOWS:

**WHEREAS**, the Town of Yorkville's 2015 General Fund annual budget was approved by the Yorkville Town Board on November 17, 2014, and

**WHEREAS**, this budget has line items where expenditures currently exceed the line item expenditures previously approved by the Yorkville Town Board, and

**WHEREAS**, Wisconsin Statutes Section 66.0607(7) requires that line items within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and

**WHEREAS**, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body.

**NOW, THEREFORE, BE IT RESOLVED**, that the Yorkville Town Board amends the 2015 Town of Yorkville General Fund annual budget with the transfers attached hereto as Exhibit "A", and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to make the budgetary amendments described above, and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to publish a summary of this resolution, as required by Town of Yorkville Code of Ordinances Section 46-126, and

**BE IT FURTHER RESOLVED**, that this resolution takes effect upon its publication.




