**A RESOLUTION TO INITIATE PROCEDURE FOR INCORPORATING
THE TOWN OF YORKVILLE AS A VILLAGE BY PROVIDING
FOR A REFERENDUM ON APRIL 3, 2018, UNLESS ANOTHER DATE IS
OTHERWISE AUTHORIZED BY THE YORKVILLE TOWN BOARD**

**THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY,
WISCONSIN, RESOLVES AS FOLLOWS:**

WHEREAS, the Town Board of Yorkville (“Town Board”), wishes to allow the electors of the Town of Yorkville the opportunity to determine whether the Town of Yorkville should incorporate and become the Village of Yorkville, as provided by Wis. Stat. § 66.0203(10); and

WHEREAS, the Town Board has verified that the Town of Yorkville shall meet the requirements for incorporation as a Village pursuant to Wis Stat sec. 66.0203(10), because it is adjacent to the Village of Mount Pleasant which shall, effective January 1, 2018, contain an electronics and information technology manufacturing zone designated under Wis Stat sec. 238.396(1m); and

WHEREAS, the Town Board wants to set a date for electors in the Town of Yorkville to vote on a referendum that will determine whether the Town of Yorkville will become the Village of Yorkville.

NOW, THEREFORE, BE IT RESOLVED,

1. The Town Board hereby initiates the procedure for incorporating the Town of Yorkville as the Village of Yorkville pursuant to Wis. Stat. § 66.0203(10), by adopting this Resolution providing for a referendum on the question of whether the Town of Yorkville should become a Village.

2. A referendum election shall be held on Tuesday, April 3, 2018, unless another date is otherwise authorized by the Town Board, pursuant to Wis. Stat. § 66.0211(3) and Wis. Stat. § 66.0217(7), to the extent applicable. The ballot question on the referendum shall contain the words “for a Village;” and “against a Village.”

3. The territory which is proposed to be incorporated includes all of the territory located within the boundaries of the Town of Yorkville as it exists as of the date of the referendum election on April 3, 2018, unless another date is otherwise authorized by the Town Board.

4. The Town Clerk for the Town of Yorkville is directed to take such actions as are necessary to implement this Resolution and schedule the referendum election.


5. The Town Clerk is further directed to post this Resolution on the Town of Yorkville’s website and to publish the Resolution as a Class 1 notice pursuant to the provisions of Chapter 985 of the Wisconsin Statutes.





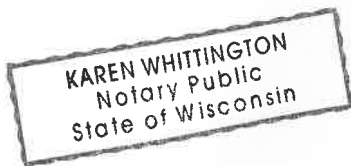
