- **WHEREAS,** Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and
- **WHEREAS,** Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body, and
- WHEREAS, the Village of Yorkville Sewer and Water Commission recommended, at their meeting on November 19, 2019, that the 2019 Sewer Utility Fund annual budget be amended with the transfers included within and attached hereto as Exhibit "A", and

- WHEREAS, the Village of Yorkville Sewer and Water Commission recommended, at their meeting on November 19, 2019, that the 2019 Water Utility Fund annual budget be amended with the transfers included within and attached hereto as Exhibit "B", and
- WHEREAS, the Village of Yorkville Sewer and Water Commission recommended, at their meeting on December 17, 2019, that the 2019 Sewer Utility Fund annual budget be amended with the transfers included within and attached hereto as Exhibit "C", and
- WHEREAS, the Village of Yorkville Sewer and Water Commission recommended, at their meeting on December 17, 2019, that the 2019 Water Utility Fund annual budget be amended with the transfer included within and attached hereto as Exhibit "D", and
- **WHEREAS,** the Village of Yorkville Sewer and Water Commission recommended, at their meeting on December 17, 2019, that the 2020 Water Utility Fund annual budget be amended with the transfer included within and attached hereto as Exhibit "E".

**BE IT FURTHER RESOLVED,** that the Clerk-Treasurer is hereby directed to publish a summary of this resolution, as required by Village of Yorkville Code of Ordinances Section 46-126, and

BE IT FURTHER RESOLVED, that this resolution takes effect upon its publication.
