WHEREAS, the Village of Yorkville's 2019 General Fund annual budget was approved by the Yorkville Village Board on November 26, 2018, and

WHEREAS, this budget has categorical line items where expenditures currently exceed the categorical line item expenditures previously approved by the Yorkville Village Board, and

WHEREAS, Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and

WHEREAS, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body.

NOW. THEREFORE, BE IT RESOLVED, that the Yorkville Village Board hereby amends the 2019 Village of Yorkville General Fund annual budget with the transfers attached hereto as Exhibit "G", and

BE IT FURTHER RESOLVED, that the Administrator/Clerk is hereby directed to make the budgetary amendments described above, and

BE IT FURTHER RESOLVED, that the Administrator/Clerk is hereby directed to publish a summary of this resolution, as required by Village of Yorkville Code of Ordinances Section 46-126, and

BE IT FURTHER RESOLVED, that this resolution takes effect upon its publication.


