

# Village Board Joint Meeting Minutes Union Grove Municipal Center 925 15th Avenue Monday, March 25, 2024

1. Village Administrator, Doug Nelson, called the meeting to order at 6:01 pm.

# 3. Consent Agenda - approval of:

- a. March 11, 2024 joint Village Board/Sewer & Water Commission and March 11, 2024, joint Village Board and Plan Commission
- b. \$16,102.99 Village Invoice

Motion (Bartlett, Funk) to approve the Consent Agenda items as presented, Motion Carried (MC).

- 4. Business Discussion and possible action on the following:
  - a. Request submitted by Brandon Bernabei for waivers of Sections 38-112 and 38-115 of the Village of Yorkville Code of Ordinances relating to the requirement that a culvert be placed under a newly installed driveway entrance and the limitation on the number of driveway entrances, to allow for an application to obtain an after-the-fact permit for a second driveway entrance located at 16300 Acorn Trail (Parcel ID # 194-03-21-27-023-200)

Mr. Bernabei stated that while building his new home, he made use of a storage container on the west end of the property and laid crushed asphalt to enable driving over the ditch when conditions were wet. There is no culvert, and no water is running lateral to the roadway there, and the water runs into the woods/marsh. The usable portion of his land is wide rather than deep and he would like to be able to take the street down to the second drive on wet days. Maurice mentioned that Bernabei may need to get a permit for the shipping container if he plans to keep it on the property. Bernabei was asked about the damage to the road in front of his property and Bernabei stated that his contractor had brought in dump trucks during the construction.

Motion (Maurice, Bartlett) to approve waivers, as presented, allowing for an after-the-fact permit for a second driveway entrance, without culvert requirement, MC.

b. Shoreland contract request submitted by the Racine County Board of Drainage Commissioners for one parcel located between 6792 2 Mile Road and 16115 2 Mile Road (Parcel ID # 194-03-21-03-002-020) in the A-2 (General Farming and Residential II) Zoning District to permit maintenance of 81 linear feet of drainage ditch at the 2 Mile Road bridge over the West Branch of the Root River Canal, with bank restoration and dredged material thin cast fill disposal, within the shoreland jurisdiction of the West Branch of the Root River Canal

Motion (S. Nelson, Maurice) to approve shoreland contract request submitted by the Racine County Board of Drainage Commissioners as presented, MC.

c. Ordinance 2024-04 Amending section 22-113 (12) of the Code of Ordinances for the Village of Yorkville, Racine County, Wisconsin, pertaining to nuisances

McKinney stated that the amendment changes language in the ordinance from "Board of Health" to "Racine County Public Health Division" as we no longer have a board of health in Racine County.

Motion (Bartlett, Funk) to approve Ordinance 2024-04 as presented, MC.

#### b. Yorkville Stormwater Utility District Report |

The agreement for dredging under the 2 Mile Bridge site is approved, RCBDC will dredge the culvert to the required depth while the bridge is out. The process is expected to run from early July through early October. Schools are aware.

#### c. Roads/Public Works Committee Report

Funk reported that the Road Tour had taken place on March 23. Bartlett had submitted all notes to McKinney and Carls. The Road Commission will continue to discuss the findings in the coming weeks. Specific mention was made of the Grandview "Swiss cheese" issue that may have been caused by mud mixed into the asphalt mix. The Grandview project will be evaluated closely, and Payne and Dolan notified of any issues identified within the warranty period. The report noted that a stop sign may be needed to address traffic issues observed at Grandview and Middle. McKinney will work on a resolution for this.

# d. Long Range Planning

Maurice stated that they had met on March 12 and the off-road vehicle ordinance changes have been sent to the Village Board for April review. Inquired about whether to consider paying LRP committee members as they are meeting 1-2 hours monthly. Upcoming discussions on storage pods, barndominiums, and minimum home sq footage are planned.

## f. Clerk Report

Carls relayed a concern about large potholes on 59<sup>th</sup> Drive's north end. She stated that letters were being drafted to address an alcohol licensing matter at Ives Grove Golf Links and will be shared with the board when completed. Carls noted that due to changes in cigarette licensing, an ordinance update will be on a future agenda.

#### g. Administrator Report

McKinney noted upcoming items for April 8<sup>th</sup>: public hearing for off-road vehicle ordinance changes; certified survey map request for Anthony & Christine Fox; conditional use extension request for Gleason – salvage; discussion regarding road bonds; a solar facility application for an accessory building on 59<sup>th</sup> DR north of 58<sup>th</sup> RD. He also noted that Racine County would be addressing the Echo Lake Foods noise complaint; they will be referred to come before the Village Board for discussion.
