## 4. Business – Discussion and possible action on the following:

# a. Short Elliott Hendrickson Wastwater System Expansion Evaluation for South Sylvania Avenue (West Frontage Road)/14017 Durand Ave (STH 11) Development presentation

Dan Schaefer presented information to the Commission pertaining to the potential extension of the sewer utility's sewer service area boundary to incorporate properties adjacent to the I-94/STH 11 interchange as well as the potential extension of sewer utility infrastructure to this interchange. Commission discussion focused on the timeline for extending the sewer service area boundary, how far the sewer service area boundary could be extended, and the potential Village and developer cost of extending sewer utility infrastructure to STH 11. Schaefer stated that the process of amending the sewer service area boundary would begin with SEWRPC. The Commission was not opposed to beginning the process of expanding the sewer service area, but asked for more information as to the potential cost of this process as well as input from the Village Board as to whether they would oppose proceeding with this expansion. The Commission agreed to discuss this agenda item again in June at a joint meeting with the Village Board.

#### a. Engineer's Report

McKinney stated that the temporary easement for relocating the walking path adjacent to planned access driveway to the water utility's water tower site expires on June 30.

#### b. Public Works Manager's Report

Carriker stated that he has completed the sewer utility's wastewater treatment plant discharge permit application. He added that he is continuing to work on compiling information related to the sewer utility's chlorides variance.

#### c. Administrator's Report

McKinney stated that he was contacted by a party interested in developing the parcel located at 2200 South Sylvania Avenue (West Frontage Road).
