PROPERTY TAX 2ND INSTALLMENTS DUE JULY 31ST TO RACINE COUNTY TREASURER

Real estate property tax 2nd installments and delinquent taxes are <u>due July 31, payable to the Racine County Treasurer</u>. Follow the instructions for payment provided with your tax bill, or your payment reminder from Racine County. Pay in person or mail tax payments to Racine County, 730 Wisconsin Ave. Racine WI 53403 (Courthouse 1st floor-north end) 8 AM – 4:30 PM Mon-Fri. A drop box for tax payments is located outside of the Courthouse building on the east side (Wisconsin Ave). Burlington City Hall, 300 N Pine St. in Burlington is a remote drop-off site.

The Village of Yorkville cannot accept any payments, nor forward any payments to Racine County on your behalf. Improper payments received by the Village will be returned to you by mail and could result in your payment being late.



YORKVILLE ELEMENTARY SCHOOL CONSTRUCTION UPDATES



Construction of a new custodial shop space is already underway on the northwest corner of the building. All deliveries will be processed here, and this new space will have a garage door to handle larger orders. This will eliminate truck deliveries to the back of the building in the recess area, providing for better student safety. Significant construction and demolition will start on Monday, June 10th, including removal of asbestos.

HISTORY SEEKERS OF UNION GROVE AREA

Did you know at one time there were nearly 75 county schools in Racine County?

The first schoolhouse built in Racine was a structure sixteen feet square, located on Main Street. It was opened in the winter of 1836.

Yorkville #4 School was first built in 1845, but burnt to the ground in 1885. A new brick, one-room school house was built in its place. The building was acquired by Yorkville 4-H in 1966 and still serves as their clubhouse today!

FIREWORKS

The Village's fireworks permit applications are available at the Village office or online at villageofyorkville.com/services/permittingand-licensing/. The Village issues separate permits for consumergrade and commercial-grade fireworks displays.



- To apply for a consumer-grade fireworks permit (e.g. fireworks purchased at local fireworks stands), submit a consumer-grade permit application and the \$10.00 permit fee at least two business days before your planned fireworks purchases.
- To apply for a commercial-grade fireworks permit, submit a commercial-grade permit application and the \$100.00 permit fee at least 3 weeks before your anticipated date of display. A copy of your BAFTE license and Certificate of Liability Insurance must be included with your permit application. Fire Department and Code Enforcement review and recommendation, followed by Village Board approval, is required.

Note: Fireworks sales are prohibited in Yorkville.

RIGHT TO FARM

On February 26, 2024, the Village Board amended section 22-111 of the Code of Ordinances for the Village of Yorkville pertaining to nuisances to reflect Wisconsin's "right to farm" law. This law directs courts to favor agricultural uses in certain legal disputes. The amended ordinance now reads:

Sec. 22-111. Prohibition; Intent.

(a) Prohibition. No person shall erect, contrive, cause, continue, maintain or permit to exist any public nuisance within the village.

(b) Intent: Right to Farm. It is the intent of this ordinance to allow the continuation of present agricultural uses and practices in the Village as protected under Wis. Stat. § 823.08. Changes in agricultural technology, practices, and scale of operation may create conflicts between agricultural and other activities. To the extent possible consistent with good public policy, the prohibition against public nuisances should not hamper agricultural production or the use of modern technology on lands and areas primarily used for agricultural purposes."

In addition, numerous permits were pulled for minor electrical, HVAC, and plumbing updates and/or repairs.

MAINTAINING BUILDINGS AND PROPERTY

Summer is a great time of year to evaluate the state of your buildings and premises, perform maintenance tasks, and plan for future repairs.

The Village of Yorkville Code of Ordinances includes requirements for maintaining existing buildings. For example, Sec. 10-97 (a) states "All buildings or structures and parts thereof shall be maintained in a safe condition and all devices or safeguards which are required by this code at the erection, alteration or repair of any building shall be maintained in good working order."

In addition, Sec. 22-115 states that blighted buildings and premises are declared to be public nuisances affecting peace and safety. Blighted buildings and premises are described as "premises existing within the village which are blighted because of faulty design or construction, failure to maintain such premises in a proper state of repair, improper management, or due to the accumulation thereon of junk, rubbish, refuse, garbage, junked vehicles, or other unsightly debris, structurally unsound fences, and other items which depreciate property values and jeopardize or are detrimental to the health, safety, morals or welfare of the people of the village."

Even simple things like a coat of paint, mowed lawns, and tidying up go a long way to keeping Yorkville looking great!

WATER SOFTENERS AND THE ENVIRONMENT

Brine discharge from water softeners can have 2. Work with a plumber to connect your softener toxic effects for aquatic plants and animals, negatively impacting local ecosystems. The Wisconsin DNR monitors the concentration of chlorides discharged by wastewater treatment plants and can require that a plant reduce the discharged by adding additional amount treatment processes to remove these chlorides. This can become costly and increase sewer rates by significant amounts.

Following are four ways you can help keep chlorides low.

1. Set your water softener to regenerate more frequently and use less salt for each cycle. This may even result in salt savings for you. Reach out to a local water softener expert for advice on minimizing salt usage while maintaining your home's softened water to a satisfactory degree.

- to only those areas you need softened water and to bypass areas such as cold tap water drinking lines and outside spigots.
- 3. Consider switching from a timer to a demandinitiated regeneration control. These are more efficient and will save you money in the long run.
- 4. If you are treating primarily for iron removal, consider switching to an iron treatment filter which does not require sodium chloride usage. Scan QR code for an example of this.

Please consider implementing a plan to help reduce your use of chlorides and ensure a healthy local ecosystem!



RECENTLY ADOPTED OFF-ROAD VEHICLE ORDINANCES

The Village Board adopted two updated off-road vehicle ordinances at their meeting on April 8, 2024. These ordinance updates made the following changes:

- 1. Expands the definition of off-road vehicles to include *motorized vehicle designed for use on a variety* of unimproved surfaces including but not limited to, dune buggies, four-wheel drive vehicles, snowmobiles, all-terrain vehicles (ATVs), utility terrain vehicles (UTVs), dirt bikes, mini-bikes, motor bikes, mopeds, and trail bikes.
- 2. Distinguishes between off-road vehicle tracks and trails.
 - a. <u>Tracks</u> are permanent and defined paths where the landscape has been manipulated in such a manner as to create a path or ruts that may include jumps, pits, obstacle courses, hills, and/or berms.
 - b. <u>Trails</u> are permanent and defined paths where the landscape has not been manipulated in such a manner as to create a path or ruts that may include jumps, pits, obstacle courses, hills, and/or berms.
- 3. Creates three classes of off-road vehicle use.
 - a. <u>Type A incidental off-road vehicle</u> activities, where the off-road vehicle is used on parcels of any size for a permitted use, such as to mow or plow snow, assist in activities related to on-site landscaping or agricultural activities, household chores, etc. These uses are not subject to any time, duration or location restrictions, do not require any village registration or permit, but are subject to general operational restrictions.
 - b. <u>Type B off-road vehicle</u> activities utilize an off-road vehicle trail for recreational purposes. These uses do not require any village registration or permit but are subject to general operational restrictions, location restrictions, and time and duration restrictions.
 - c. <u>Type C off-road vehicle</u> activities utilize an off-road vehicle track. These uses are required to obtain a conditional use permit and comply with additional site restrictions.
- 4. Establishes parcel size limitations for off-road vehicle operation. Off-road vehicles involved in *Type B* activities may be operated in agriculturally zoned areas (A-2) on lots of at least three acres in size, and *Type C* activities may be operated in Agricultural (A-2), Commercial (B-2, B-5), or Recreational Park (P-2) zoning districts on lots of at least five acres in size.
- 5. Establishes time and duration restrictions for off-road vehicle operation. Off-road vehicles involved in *Type B* or *Type C* activities may be operated only between the hours of 9:00 a.m. and 8:00 p.m., Monday through Saturday, and 12:00 p.m. and 8:00 p.m. on Sundays. Also, *Type B* and *Type C* activities may not continue for more than three hours (cumulatively) in any day.
- 6. Removes the language from the ordinance restricting the operation of off-road vehicles at any given time on a property to no more than three riders, including no more than two riders who do not reside at the property.
- 7. Exempts the following from this ordinance: agricultural equipment (such as farm tractors, seeders, combines, cultivators, etc.) used in the operation of a farm, garden tractors, riding lawnmowers, and operations where the operator is engaged in activities at the direction of and under contract with a municipality.

2023 LATE LOTTERY CREDIT DEADLINE

The deadline to file a 2023 Late Lottery Credit is October 1, 2024. The form is to be filed online with the Wisconsin Department of Revenue at <u>www.revenue.wi.gov/</u><u>Pages/Form/lottery-home.aspx</u>. The site also contains walkthrough videos and answers to common questions including who qualifes for the credit.





To see if you received the credit, review your property tax bill. The Lottery and Gaming Credit is located below the Total (tax) and First Dollar Credit lines on your tax bill. If an amount is listed on this line, the property received the credit. If it is missing, you may have applied with the Village of Yorkville Treasurer before January 31, 2024, and received the 2023 lottery credit as a refund or credit at the time of payment.

OPEN BURNING

Before burning, check the restrictions at <u>https://apps.dnr.wi.gov/wisburn/#/</u>. Fire conditions change quickly, so it's important to check each day you burn.

Be sure that you notify the Union Grove Fire Department (262) 878-4181 and the Racine County Sheriff's Department (262) 886-3300 before burning.

All burning shall be conducted when wind and weather conditions are such as to minimize adverse effects and not create a health hazard or a visibility hazard on roadways, railroads, or airfields.

No open burning shall be undertaken during periods when the fire chief or the state department of natural resources has issued a burning ban for the area.

Open burning shall be conducted only on the property on which the materials were generated.

Outdoor campfires for cooking or recreation are allowed provided that the fire is confined by a control device or structure such as fire ring or pit. Bonfires are allowed only if approved by the fire chief.

Open burning shall only be conducted at a location at least 25 feet from any structure and ten feet from any property line.

Open burning shall only be conducted between 9 AM. and the earlier of the following: Sunset or 7 PM. Recreational fires shall be out by 12 AM.

Open burning shall be constantly supervised until the fire is extinguished and is cold. The person shall have readily available fire extinguishing equipment necessary to control the fire.

No materials may be burned upon any street, curb, gutter or sidewalk or on the ice of a lake, pond, stream or waterbody.

No open burning may be conducted on days when the department of natural resources has declared an ozone action day applicable to Racine County.

Fires shall not be ignited with flammable or combustible liquids, such as gasoline, kerosene, fuel oil, diesel fuel, etc.

Summer time! Thoughts of baseball, picnics, and vacations! Please think Safety First", even if it takes a little extra time.



Put sunscreen on when outdoors and reapply often. Remember to also wear a hat for extra protection.

When bike riding, wear a helmet and bright clothing. Make sure you have lights on your bike if riding at night. If you are driving, give bicyclists plenty of room.



Make sure grills are ten feet away from anything flammable. Place the coals from your grill in a metal container with a lid AFTER they have cooled. And be sure to clean your grill after each use as excess grease can cause a fire.



Campfires also need to be a safe distance away from anything flammable, be in an approved fire pit or a carefully constructed one. Please make sure the fire is completely out before leaving.



Make sure that you are well hydrated and take breaks in the shade often when it is hot outside. Watch the news and stay informed of severe weather.
