## VILLAGE OF YORKVILLE RACINE COUNTY, STATE OF WISCONSIN

A RESOLUTION RECOMMENDING APPROVAL OF AN AMENDMENT TO THE VILLAGE OF YORKVILLE'S COMPREHENSIVE PLAN AS SET FORTH IN A DOCUMENT ENTITLED "VILLAGE OF YORKVILLE 2020-2050 COMPREHENSIVE PLAN"

THE PLAN COMMISSION OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVES AS FOLLOWS:

WHEREAS, the Village of Yorkville is performing an update to the existing Village of Yorkville 2020-2050 Comprehensive Plan ("Comprehensive Plan") to address solar energy systems and the development of solar farm sites; and

WHEREAS, the Long Range Planning/Ordinance Committee of the Village of Yorkville has reviewed, discussed and recommended adoption of the proposed amendment to the Comprehensive Plan as summarized in the memorandum from the Village's land use planner, dated August 12, 2024 with attached document showing the proposed revisions to the Comprehensive Plan ("Amendment"), which is incorporated herein by reference; and

WHEREAS, the Village Plan Commission finds that the proposed Amendment contains all of the required elements specified in §66.1001(4)(d) of Wisconsin Statutes and complies with the public participation procedures for Comprehensive Plan amendments previously adopted by the Village Board of Trustees, and agrees with the recommendation of the Long Range Planning/Ordinance Committee.

**NOW, THEREFORE, BE IT RESOLVED,** that pursuant to Section 66.1001(4)(b) of the Wisconsin Statutes, the Village of Yorkville Plan Commission hereby recommends approval of the Amendment to the Village of Yorkville's Comprehensive Plan as set forth in the memorandum from the Village's land use planner, dated August 12, 2024 with attached document showing the proposed revisions to the document entitled "Village of Yorkville 2020-2050 Comprehensive Plan," which is incorporated herein by reference; and

**BE IT FURTHER RESOLVED,** that the Plan Commission, by a majority vote of the entire Commission, does hereby recommend that the Village Board enact an Ordinance adopting this Comprehensive Plan Amendment.
