**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY,  
WISCONSIN, RESOLVES AS FOLLOWS:**

**WHEREAS**, the Village of Yorkville's 2020 Sewer Utility Fund annual budget was approved by the Yorkville Sewer and Water Commission on November 19, 2019, and

**WHEREAS**, the Village of Yorkville's 2020 Water Utility Fund annual budget was approved by the Yorkville Sewer and Water Commission on November 19, 2019, and

**WHEREAS**, the Village of Yorkville's 2020 Sewer Utility Fund annual budget was approved by the Yorkville Village Board on November 25, 2019, and

**WHEREAS**, the Village of Yorkville's 2020 Water Utility Fund annual budget was approved by the Yorkville Village Board on November 25, 2019, and

**WHEREAS**, the Village of Yorkville's 2020 General Fund annual budget was approved by the Yorkville Village Board on November 25, 2019, and

**WHEREAS**, these budgets have individual line items where expenditures currently exceed the line item expenditures previously approved by the Yorkville Sewer and Water Commission and the Yorkville Village Board, and

**WHEREAS**, Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and

**WHEREAS**, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body, and

**WHEREAS**, the Village of Yorkville Sewer and Water Commission recommended, at their meeting on December 15, 2020, that the 2020 Sewer Utility Fund annual budget be amended with the transfers included within and attached hereto as Exhibit "C", and

**WHEREAS**, the Village of Yorkville Sewer and Water Commission recommended, at their meeting on December 15, 2020, that the 2020 Water Utility Fund annual budget be amended with the transfers included within and attached hereto as Exhibit "D".

**NOW, THEREFORE, BE IT RESOLVED**, that the Yorkville Village Board hereby amends the 2020 Village of Yorkville Sewer Utility Fund annual budget with the transfers attached hereto as Exhibit "C", based upon the recommendation made by the Village of Yorkville Sewer and Water Commission at their meeting on December 15, 2020, and

**BE IT FURTHER RESOLVED**, that the Yorkville Village Board hereby amends the 2020 Village of Yorkville Water Utility Fund annual budget with the transfers attached hereto as Exhibit “D”, based upon the recommendation made by the Village of Yorkville Sewer and Water Commission at their meeting on December 15, 2020, and

**BE IT FURTHER RESOLVED**, that the Yorkville Village Board hereby amends the 2020 Village of Yorkville General Fund annual budget with the transfers attached hereto as Exhibit “E”, and

**BE IT FURTHER RESOLVED**, that the Treasurer is hereby directed to make the budgetary amendments described above, and

**BE IT FURTHER RESOLVED**, that the Administrator/Clerk is hereby directed to publish a summary of this resolution, as required by Village of Yorkville Code of Ordinances Section 46-126, and

**BE IT FURTHER RESOLVED**, that this resolution takes effect upon its publication.
