**VILLAGE OF YORKVILLE
RACINE COUNTY, WISCONSIN**

**A RESOLUTION ADOPTING AN AMENDMENT TO THE BOND SCHEDULE FOR BRANCH 2 -
YORKVILLE OF THE JOINT MUNICIPAL COURT OF THE TOWN OF DOVER AND THE VILLAGE
OF YORKVILLE**

**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN,
RESOLVES AS FOLLOWS:**

WHEREAS, in accordance with Wisconsin Statutes Section 755.01, the Village of Yorkville is a participating municipality in the Municipal Court for the Town of Dover and the Village of Yorkville, and

WHEREAS, the Municipal Court for the Town of Dover and the Village of Yorkville operates a separate branch for the Village of Yorkville, herein referred to as the “Municipal Court – Branch 2”, and

WHEREAS, the deposit schedule applicable to various Municipal Court citations is required to be established by the Municipal Court with the approval of the Yorkville Village Board for all cases other than cases arising under the vehicle code or the boating code where the deposit schedule is established by the State of Wisconsin, and

WHEREAS, the Village of Yorkville has established its deposit schedule by resolution and maintained the schedule as a freestanding document, which is permissible under Wisconsin Statutes Section 800.037, and

WHEREAS, Judge Heather Niski, the presiding Municipal Judge for the Municipal Court for the Town of Dover and the Village of Yorkville, has authorized the following additions to the approved bond schedule for Municipal Court citations in zoning violations:

| Chapter 55- Sec. 20-12 | General Penalty for Zoning Code Violations | \$20.00 to \$1,000.00 Continuing Daily Violations | \$250.00 | \$376.00 |

NOW, THEREFORE, BE IT RESOLVED, that the Yorkville Village Board declares that the bond schedule shall be modified to add the additions specified above within the jurisdictional limits of the Village of Yorkville that are processed in the Municipal Court-Branch 2, other than cases arising under the vehicle code or the boating code where the deposit schedule is established by the State of Wisconsin, and

BE IT FURTHER RESOLVED, that all changes made in the future to this bond schedule shall be made by the presiding judge of the Municipal Court for the Town of Dover and the Village of Yorkville, but shall not take effect until they are approved by the Yorkville Village Board, and

BE IT FURTHER RESOLVED, that all future Village bonds, as well as any necessary amendments to the Village bond schedule, shall be incorporated into the Village of Yorkville bond schedule upon their adoption, and

BE IT FURTHER RESOLVED, that the Yorkville Village Administrator/Clerk shall keep the Village of Yorkville bond schedule in the Village office and make such schedule available for public inspection at all times during normal business hours and shall provide a copy to the Municipal Court Judge, and

BE IT FURTHER RESOLVED, that the Village Administrator/Clerk is hereby directed to post this resolution as required by Wisconsin law, and

BE IT FURTHER RESOLVED, that this resolution takes effect the day following its posting.

This Resolution was adopted by the Yorkville Village Board on April 26, 2021.
