A RESOLUTION AMENDING THE VILLAGE OF YORKVILLE'S 2021 GENERAL FUND AND SEWER UTILITY FUND ANNUAL BUDGETS

THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVES AS FOLLOWS:

- **WHEREAS,** the Village of Yorkville's 2021 Sewer Utility Fund annual budget was approved by the Yorkville Sewer and Water Commission on October 20, 2020, and
- **WHEREAS**, the Village of Yorkville's 2021 Sewer Utility Fund annual budget was approved by the Yorkville Village Board on November 23, 2020, and
- **WHEREAS,** the Village of Yorkville's 2021 General Fund annual budget was approved by the Yorkville Village Board on November 23, 2020, and
- WHEREAS, these budgets have individual line items where expenditures currently exceed the line item expenditures previously approved by the Yorkville Sewer and Water Commission and the Yorkville Village Board, and
- **WHEREAS**, Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and
- **WHEREAS,** Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body, and
- **WHEREAS,** the Village of Yorkville Sewer and Water Commission will consider, at their meeting on March 15, 2022, the proposed 2021 Sewer Utility Fund annual budget amendment with the transfers included within and attached hereto as Exhibit "A".
- **NOW, THEREFORE, BE IT RESOLVED,** that the Yorkville Village Board hereby amends the 2021 Village of Yorkville Sewer Utility Fund annual budget with the transfers attached hereto as Exhibit "A", with any further action on this amendment conditioned upon the recommendation, if any, made by the Village of Yorkville Sewer and Water Commission at their meeting on March 15, 2022, and
- **BE IT FURTHER RESOLVED,** that the Yorkville Village Board hereby amends the 2021 Village of Yorkville General Fund annual budget with the transfers attached hereto as Exhibit "B", and
- **BE IT FURTHER RESOLVED,** that the Treasurer is hereby directed to make the budgetary amendments described above, and

BE IT FURTHER RESOLVED, that the Administrator/Clerk is hereby directed to publish a summary of this resolution, as required by Village of Yorkville Code of Ordinances Section 46-126, and

BE IT FURTHER RESOLVED, that this resolution takes effect upon its publication.
