**A RESOLUTION AMENDING THE VILLAGE OF YORKVILLE'S 2022 GENERAL FUND  
ANNUAL BUDGET**

**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVES AS FOLLOWS:**

**WHEREAS**, the Village of Yorkville's 2022 General Fund annual budget was approved by the Yorkville Village Board on November 22, 2021, and

**WHEREAS**, this budget has individual line items where expenditures currently exceed the line item expenditures previously approved by the Yorkville Village Board, and

**WHEREAS**, Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and

**WHEREAS**, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body.

**NOW, THEREFORE, BE IT RESOLVED**, that the Yorkville Village Board hereby amends the 2022 Village of Yorkville General Fund annual budget with the transfers attached hereto as Exhibit "A", and

**BE IT FURTHER RESOLVED**, that the Treasurer is hereby directed to make the budgetary amendments described above, and

**BE IT FURTHER RESOLVED**, that the Administrator/Clerk is hereby directed to publish a summary of this resolution, as required by Village of Yorkville Code of Ordinances Section 46-126, and

**BE IT FURTHER RESOLVED**, that this resolution takes effect upon its publication.

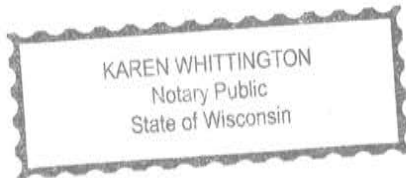
