- **WHEREAS**, the Village of Yorkville's 2022 Sewer Utility Fund annual budget was approved by the Yorkville Sewer and Water Commission on October 19, 2021, and
- **WHEREAS,** the Village of Yorkville's 2022 Sewer Utility Fund annual budget was approved by the Yorkville Village Board on November 22, 2021, and
- WHEREAS, the Village of Yorkville's 2022 Water Utility Fund annual budget was approved by the Yorkville Sewer and Water Commission on October 19, 2021, and
- **WHEREAS**, the Village of Yorkville's 2022 Water Utility Fund annual budget was approved by the Yorkville Village Board on November 22, 2021, and
- WHEREAS, these budgets have individual line items where expenditures currently exceed the line item expenditures previously approved by the Yorkville Sewer and Water Commission and the Yorkville Village Board, and
- **WHEREAS,** Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and
- **WHEREAS,** Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body.
- **NOW, THEREFORE, BE IT RESOLVED,** that the Yorkville Village Board hereby amends the Village of Yorkville's 2022 Sewer Utility Fund annual budget with the transfers attached hereto as Exhibit "A", and
- **BE IT FURTHER RESOLVED**, that the Yorkville Village Board hereby amends the Village of Yorkville's 2022 Water Utility Fund annual budget with the transfers attached hereto as Exhibit "B", and
- **BE IT FURTHER RESOLVED,** that the Treasurer is hereby directed to make the budgetary amendments described above, upon approval of these same amendments by the Yorkville Sewer and Water Commission, and
- **BE IT FURTHER RESOLVED,** that the Administrator/Clerk is hereby directed to publish a summary of this resolution, as required by Village of Yorkville Code of Ordinances Section 46-

126, upon approval of these same amendments by the Yorkville Sewer and Water Commission, and

BE IT FURTHER RESOLVED, that this resolution takes effect upon its publication.
