**A RESOLUTION AMENDING THE VILLAGE OF YORKVILLE'S 2023 GENERAL  
FUND AND SEWER UTILITY FUND ANNUAL BUDGETS**

**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, RACINE COUNTY,  
STATE OF WISCONSIN, RESOLVES AS FOLLOWS:**

**WHEREAS**, the Village of Yorkville's 2023 General Fund annual budget was approved by the Yorkville Village Board on November 28, 2022; and

**WHEREAS**, the Village of Yorkville's 2023 Sewer Utility Fund annual budget was approved by the Yorkville Sewer and Water Commission on October 18, 2022; and

**WHEREAS**, the Village of Yorkville's 2023 Sewer Utility Fund annual budget was approved by the Yorkville Village Board on November 28, 2022; and

**WHEREAS**, these budgets have individual line items where expenditures currently exceed the line item expenditures previously approved by the Yorkville Sewer and Water Commission and the Yorkville Village Board; and

**WHEREAS**, Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders; and

**WHEREAS**, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body; and

**WHEREAS**, the Village of Yorkville Sewer and Water Commission recommended, at their meeting on February 20, 2024, that the 2023 Sewer Utility Fund annual budget be amended with the transfers included within and attached hereto as Exhibit "B".

**NOW, THEREFORE, BE IT RESOLVED**, that the Yorkville Village Board hereby amends the Village of Yorkville's 2023 General Fund annual budget with the transfers attached hereto as Exhibit "A"; and

**BE IT FURTHER RESOLVED**, that the Yorkville Village Board hereby amends the Village of Yorkville's 2023 Sewer Utility Fund annual budget with the transfers attached hereto as Exhibit "B"; and

**BE IT FURTHER RESOLVED**, that the Treasurer/Finance Director is hereby directed to make the budgetary amendments described above; and

**BE IT FURTHER RESOLVED**, that the Clerk is hereby directed to publish a summary of this resolution, as required by Village of Yorkville Code of Ordinances Section 46-126, upon approval of these same amendments by the Yorkville Sewer and Water Commission; and

**BE IT FURTHER RESOLVED**, that this resolution takes effect upon its publication.

This Resolution was adopted by the Yorkville Village Board on February 26, 2024.


