#### **EXHIBIT A - CONDITIONS**

Chad and Amy Thur, Owner Satter Surveying, LLC/Thomas Satter, Applicant/Agent

- 1. <u>Reimburse Village Costs.</u> Applicant shall reimburse the Village for all costs incurred by the Village for review of this request, including but not limited to engineering, legal and planning review.
- 2. <u>Drain Tile Acknowledgement.</u> The following language shall be added to the final certified survey map prior to its execution by the Village President and Village Clerk: "Per the land division ordinance of the Village of Yorkville, the owner shall reconstruct, relocate or replace any tile line which may be disturbed by the development of a lot created by a minor subdivision so as to provide for the continued operation of such tile line as before development of such lot. The lot owner shall be responsible for the future maintenance, operation, and replacement of all private storm/surface water facilities, including drain tiles whether previously mapped or subsequently discovered."
- 3. Storm Water Easement. Twenty-foot-wide storm water easements that are centered on the known locations of drain tile lines on the parent parcel subject to this final certified survey map shall be depicted on the final certified survey map prior to its execution by the Village President and Village Clerk. Each easement shall include all land within ten feet of the location of each known drain tile line on the parent parcel subject to this final certified survey map. A legal description shall also be drafted describing the location of each storm water easement established by this condition.
- 4. <u>Storm Water Easement Agreement.</u> A storm water easement agreement addressing the above-described storm water easement(s) shall be approved by the Village Board and recorded with the Racine County Register of Deeds upon execution and recording of this final certified survey map with the Racine County Register of Deeds.




