**AN ORDINANCE TO AMEND SECTION 2-231 OF THE CODE OF ORDINANCES OF
THE VILLAGE OF YORKVILLE, COUNTY OF RACINE, STATE OF WISCONSIN,
RELATING TO THE MEMBERSHIP AND TERM OF THE BOARD OF REVIEW**

The Village Board of the Village of Yorkville, County of Racine, State of Wisconsin, ordains as follows:

1. That Section 2-231 of the Code of Ordinances of the Village of Yorkville, be, and hereby is, amended to read as follows on the attached “**EXHIBIT A**” incorporated herein by reference.

2. That this ordinance shall become effective upon adoption and publication as provided by law.

EXHIBIT A

Sec. 2-231. Membership and Term of the Board of Review

- (a) The Village Board of Review shall consist of a combination of five Village Residents and all the Village Trustees serving terms as defined in 2-231(b).
 - (1) Village Resident Members
 - a. Appointment and Term: Five Village Residents shall be appointed to the Board of Review by the Village Board for a term of two years.
 - b. Citizen Service Status: These five residents shall alternate their service as either standing members or alternate members of the Board on an annual basis, as defined in the annual composition below.
- (b) Annual Composition and Service. The composition of the standing Board of Review shall rotate annually as described in (1) and (2), below.
 - (1) Even Years (Non-Election Years for Three Trustees). The standing Board shall consist of the following five members:
 - a. Three Village Trustees who are not up for reelection in that year.
 - b. Two Village Residents (appointed citizens).
 - c. The remaining three Village Residents shall serve as Alternate Members.
 - (2) Odd Years (Non-Election Years for Two Trustees). The standing Board shall consist of the following five members:
 - a. Two Village Trustees who are not up for reelection in that year.
 - b. Three Village Residents (appointed citizens).
 - c. The remaining two Village Residents shall serve as Alternate Members.
- (c) Alternate Member Service. Alternate Members shall only serve on the Board when a standing member is removed from an individual case due to a conflict of interest or other disqualification. Wis. Stat. § 70.47 (6m)(c).
- (d) Exclusions. No Village official, including the Village Assessor, who has direct involvement in the assessment of property shall be eligible to serve as a member or alternate member of the Board of Review.

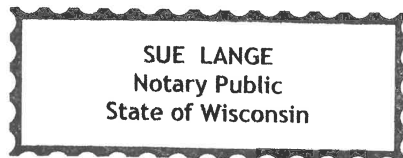
