**A RESOLUTION UPDATING THE FEE SCHEDULE FOR FEES ESTABLISHED BY  
YORKVILLE VILLAGE BOARD POLICY AND VARIOUS PROVISIONS OF THE  
VILLAGE OF YORKVILLE CODE OF ORDINANCES**

**THE VILLAGE BOARD OF THE VILLAGE OF YORKVILLE, COUNTY OF  
RACINE, STATE OF WISCONSIN, RESOLVES AS FOLLOWS:**

**WHEREAS**, the Yorkville Village Board enacted Resolution 2023-17 on June 26, 2023, which is an abbreviated and uniform schedule of fees established and charged by the Village of Yorkville per Yorkville Village Board policy and various provisions of the Village of Yorkville Code of Ordinances; and

**WHEREAS**, the Yorkville Village Board may update this fee schedule by adoption of a resolution, from time to time and as the need arises, if the fees enumerated within are not sufficient to defray the costs for which those fees are collected and intended to cover or if changes to the Village of Yorkville Code of Ordinances require that said changes be made.

**NOW, THEREFORE, BE IT RESOLVED**, by the Village Board of the Village of Yorkville, County of Racine, State of Wisconsin, that the fees for certain services are either not sufficient to defray the costs for which those fees are collected and intended to cover or must be changed to reflect updates made to the Village of Yorkville Code of Ordinances; and

**BE IT FURTHER RESOLVED**, that the Village of Yorkville fee schedule be amended with the updates attached as "**EXHIBIT A**"; and

**BE IT FURTHER RESOLVED**, that the fees enumerated in Exhibit A supersede and replace any existing fees for the same purposes, including those listed within the Village of Yorkville Code of Ordinances, and remain in full force and effect until modified by further resolution of the Yorkville Village Board.
