By signing the Consumer-Grade Fireworks Permit application, the applicant agrees to the following:

- That no fireworks shall be used or displayed that are prohibited by the State of Wisconsin.
- That no commercial-grade fireworks (e.g., Division 1.3 explosives) shall be used.
- That no fireworks shall be sold or purchased within Village limits.
- That fireworks shall not be used before dusk or after 11:00 p.m., unless otherwise approved by the Village Board.
- That the applicant shall obtain the consent of the property owner of the described property prior to displaying fireworks there.
- That only the applicant or their designee can use or display fireworks at the above-described property under this permit.
- That this permit may be cancelled and rescheduled by the Village if the weather or other situations make it unsafe to display fireworks or if the Village Board determines that the permit was issued based upon fraud or misrepresentation.
- That this permit is NOT a guarantee by the Village of Yorkville that the use of fireworks is safe.
- That the applicant hereby indemnifies and holds the Village harmless for all claims related to the possession or use of fireworks pursuant to Wis. Stat. § 167.10(7m).
- That a parent, foster parent, or legal guardian of a minor who consents to the minor's use of fireworks is liable for all damages caused by the minor's use pursuant to Wis. Stat. § 167.10(7).
